
- If approved; this appropriation funding will fund Municipal Conference Center ADA building codes upgrades. These upgrades feature modernization of elevator equipment controllers, call buttons, hall lanterns, voice annunciators, and cab finishes to ten (10) elevators along with improvements to electrical and life safety systems located throughout the Bartle Exhibit Halls and Conference Center Ballrooms venue areas.
- While the life and safety systems include a new elevator pit, machine room lighting and receptacles, new machine room HVAC, new smoke and heat detectors and modifications to existing alarm and fire sprinkler systems.
- Interior work will also involve drywall, miscellaneous interior patch and repair work, hollow metal doors and hardware, new handrail guards, fire stopping, sealant applications, painting, and signage.
