WHEREAS, Section 3-41(a)(2), Code of Ordinances, requires the Manager of Procurement Services to obtain City Council authorization to enter into contracts for services that may exceed \$400,000.00; and

WHEREAS, it is estimated that the City will spend \$1,470,379.16 per year; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Manager of Procurement Services is authorized to execute a term and supply contract with Arcwood Environmental, LLC, for Contract No. EV4375, Household Hazardous Waste Operation. A copy of the contract is on file in the Procurement Services Division.

Section 2. That the Manager of Procurement Services is authorized to amend the contract and exercise five (5) one-year renewal options for this contract without additional Council authorization with such funds as appropriated by the City Council in future annual budgets.

Reason for Contract

KC Water operates a Household Hazardous Waste (HHW) Facility and program to help protect area streams and rivers and keep hazardous materials out of landfills. HHW offers a safe method for residents of Kansas City and area participating communities to remove hazardous waste from homes.

Contract Description

This contract provides comprehensive services for the operation of the Household Hazardous Waste Facility including staffing of the public access and operations areas, mobile event collections, product reuse, waste management and disposal, customer service, federal, state, and local compliance, general facility maintenance and upkeep. In addition, the Contractor shall also provide certain services in the event of an emergency response situation within City limits.

This contract is available to all City departments requiring the services provided under this contract.
