WHEREAS, the proposed annual budget for the Shops on Blue Parkway Community Improvement District is marked **Exhibit "A"**, attached hereto and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED:

- 1. **Exhibit "A"** is approved as the annual budget for the 2023 thru 2024 fiscal year.
- 2. The Board of Directors is authorized and directed to submit the annual budget to the governing body of the City of Kansas City, Missouri pursuant to Section 67.1471.2 RSMo.
- 3. The Board of Directors is directed to provide copies of any comments made by the governing body about the annual budget to the board of directors within seven days of receipt.

The foregoing resolution was adopted in accordance with the Community Improvement District Act and the laws of the State of Missouri. The Board of Directors of the Shops on Blue Parkway Community Improvement District has full power and authority to bind the Shops on Blue Parkway Community Improvement District pursuant to this resolution. This resolution is in full force and effect and has not been altered, modified or rescinded.

NOW, THEREFORE, BE IT:

RESOLVED, that Robert Langenkamp, Emmet Pierson, Jr., Shannon Hesterberg, and Felicia Mann of the Corporation, and Kim Cronan of Colliers, are hereby duly appointed to serve as the legally authorized representatives of Community Builders of Kansas City, an owner of real property in the Shops on Blue Parkway Community Improvement District (CID), for all purposes in connection with service on the Board of Directors of the CID pursuant to Section 67.1451 through 67.1571, RSMo.; and

FURTHER RESOLVED, that Robert Langenkamp, Emmet Pierson, Jr., Shannon Hesterberg, and Felicia Mann of the Corporation, and Kim Cronan of Colliers, are further authorized and directed to take any and all further action they deem necessary to secure their election to the Board of Directors of the CID.
