# **Executive Summary**

Authorizing a \$4,214,565.00 construction contract with SHEDIGS IT, LLC, for the Hardesty and 63<sup>rd</sup> Street 36-Inch Transmission Main Replacement project; and authorizing a maximum expenditure of \$4,636,021.00.

#### **Discussion**

#### **Project Justification**

The Water Services Department is undertaking this construction project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection to replace aging, break-prone prestressed concrete cylinder pipe (PCCP) water mains with ductile iron pipe (DIP).

#### **Project Description**

This project includes the replacement of approximately 3,825 LF of 36-inch break-prone PCCP water main with 36-inch DIP water along Hardesty Avenue from East 63rd Street to approximately 3,825 LF north near 5640 Hardesty Avenue, in Kansas City, Jackson County, Missouri.

The work will include the transfer of customers' water service connections from existing water mains to new water mains. The amount of this contract is \$4,214,565.00.

#### Term

The term of this contract is 270 calendar days.

#### MBE/WBE Goals

CREO KC established goals of 11% MBE and 11% WBE on this project on July 15, 2024 as part of the Annual Goal Program.

#### Solicitation

This project was advertised in accordance with the City's requirements. Public bids were opened on August 20, 2024 with 8 bidders responding.

#### <u>Awardee/Subcontracting Participation</u>

SHEDIGS IT, LLC was selected for this project as the lowest, most responsive, and most responsible bidder with a contract amount of \$4,214,565.00, with subcontracting participation of 11% MBE and 50% WBE.
