## TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The <u>Maximum School Speed Limit</u>, as indicated below and as listed in <u>Section 70-363</u>, is hereby discontinued at the following location(s):

Prohibition of <u>Stopping</u>, <u>Standing and/or Parking</u>, as indicated below and as listed in <u>Section 70-530</u> is hereby discontinued at the following location(s):

64102	9 <sup>th</sup> Street, south side, from Main Street to Walnut Street	No Parking Anytime
64103	9 <sup>th</sup> Street, south side, from Walnut Street to Grand Avenue	No Parking 7:00 AM to 6:00 PM Monday Through Friday

64104	9 <sup>th</sup> Street, south side, from Grand Avenue to McGee Street	No Parking 7:00 AM to 6:00 PM Monday Through Friday
64105	Summit Street, west side, from 18 <sup>th</sup> Street then south 50 feet	No Parking Anytime

Prohibition of <u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below and as listed in <u>Section 70-531</u> and <u>70-591</u> is hereby discontinued at the following location(s):

64106	Troost Avenue, east side, from a point 363 feet north of 30 <sup>th</sup> Street then north 97 feet	Two Hour Parking

Reserved Parking for <u>Physically Disabled Persons</u>, as indicated below and as listed in <u>Sections 70-534</u> and <u>70-535</u> is hereby discontinued at the following location(s):

64107	Brighton Avenue, west side, from a point 578 feet south of 24 <sup>th</sup> Street then south 29 feet	Handicapped Parking
64108	Holmes Street, west side, from a point 185 feet north of 42 <sup>nd</sup> Street then north 25 feet	Handicapped Parking
