<p>Discussion <i>(including relationship to other Council actions)</i></p> <p>It is the desire of the Board of Parks and Recreation Commissioners to enhance and expand the Indian Creek Greenway by adding one unimproved lot located at 1405 E. Bannister which will expand the Indian Creek Greenway for a walking trail and stream bank preservation. Indian Creek Greenway is a 119.49 acre greenway whose assembly began in 1968 and is generally located between State Line Road on the west to the Blue River on the east.
