

ORDINANCE NO. 170968

Estimating revenue in the amount of \$485,000.00 in the Capital Improvements Sales Tax Fund; appropriating that amount to the North Brighton Avenue accounts; authorizing the Director of Public Works to enter into an agreement with the Tax Increment Financing Commission of Kansas City, Missouri for the North Brighton Avenue improvements from N.E. Pleasant Valley Road to N.E. 78th Street project; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, Ordinance No. 160592 approved the twelfth amendment to the Shoal Creek Tax Increment Financing Plan; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That revenue in the following in account of the Capital Improvements Fund is hereby estimated in the following amount:

Section 2. That the amount of \$485,000.00 is hereby appropriated from the Unappropriated Fund Balance of the Capital improvements Fund to the following accounts:

Section 3. That the Director of Public Works is hereby authorized to execute an agreement with the Tax Increment Financing Commission in the amount of \$485,000.00 for funding Project No. 89008201 - N. Brighton Avenue improvements from N.E. Pleasant Valley Road to N.E. 78th Street.

Section 4. That this ordinance, relating to the design, repair, maintenance or construction of a public improvement is recognized as an ordinance with an accelerated effective date as provide by Section 503(a)(3)(D) of the City Charter and shall take effect in accordance with Section 503, City Charter.


