250226 Sponsor: Director of Aviation Department

Authorizing the Director of Aviation to accept the proposal of Oshkosh Airport Products Inc., for the acquisition of aircraft rescue firefighting vehicles and equipment at an estimated cost of \$1,739,840.00; authorizing the execution of all documents and agreements necessary for the acquisition; and designating requisitioning authority.

This ordinance authorizes the Director of Aviation to accept the proposal from Oshkosh Airport Products Inc. for the acquisition of aircraft rescue firefighting vehicles and equipment at an estimated cost of \$1,739,840.00. It also grants the authority to execute all necessary documents and agreements to complete the acquisition and designates requisitioning authority for the process. The funds will be used by contracts with Della Lamb Community Services and Jewish Vocational Service of Kansas City to provide emergency housing assistance and case management services to refugees and immigrants in need.

Phineas Sachs, Mayor's Office, presented this Resolution. This resolution approves the appointment of Theresa Otto as a regular member of the Board of Zoning Adjustment (BZA) and the reappointment of Emerson Hayes and Michael Meier as alternative members. Additionally, it approves the appointment of Gonzalo Ventura as an alternative member of BZA. A current member will be vacating their position due to relocating to a different city, which is the reason for the appointment of Theresa Otto. Ms. Otto will complete the remaining 2 years of the 5-year term of the vacancy. The alternative members will serve 1-year terms.

Authorizing an agreement not to exceed \$46,717,626.00 with the Kansas City Area Transportation Authority (KCATA) to provide transit services for the City of Kansas City, Missouri between May 1, 2025 and October 31, 2025 from funds appropriated in the 2025-2026 Annual Budget; and establishing a policy of enhanced oversight of KCATA operations to ensure fiscal accountability.

Sponsors: Lucas, Parks-Shaw, Patterson Hazley, Duncan, Curls and O'Neill

Mayor Pro Tem Parks Shaw, Jason Waldron, and Angela Laurie, Public Works, presented this ordinance. This ordinance authorizes an agreement with the Kansas City Area Transportation Authority (KCATA) for transit services for \$46,717,626.00, covering the period from May 1, 2025, to October 31, 2025, using funds appropriated in the 2025-2026 Annual Budget. Additionally, the ordinance establishes a policy of enhanced oversight of KCATA operations to ensure fiscal accountability and proper management of public resources. There were roughly 20-plus members of the public allowed to share one minute of testimony during the meeting. The public expressed concerns about suspending the IRIS program and under funding the KCATA transportation system. A copy of this presentation is on file with the Clerk's Office.

Approving a plan of finance for City's contribution to the Northland Workforce Development Center; establishing Fund No. 3456, 2026A Taxable Special Obligation Bond Fund; estimating and appropriating bond proceeds in the amount of \$29,500,000.00 for the purpose of providing the City's contribution to the project; authorizing the City Manager to execute an agreement to establish certain conditions for the City's contribution; directing the City Manager, as necessary, to identify in the initial quarterly budget clean-up sources to fill any funding gaps existing in project delivery; and declaring the effective date of this ordinance to be May 1, 2025.
