Details

Reason for Contract
 Authorizing a \$6,656,801.50 contract with Ideker, Inc., for the Rehabilitation of Taxiway C at KCI Airport; authorizing a maximum expenditure of \$7,322,481.50. This contract will be meeting the DBE goals set by the Aviation Department's DBE Program Manager.

Project Justification: Taxiway C was evaluated by a combination of visual inspections, nondestructive testing and sampling of cores taken from the taxiway pavement. Analysis indicates that this concrete must be removed and replaced to continue safe aircraft operations. This project will provide necessary improvements to Taxiway C at Kansas City International Airport.

Project Description
 The contract will provide for the removal and replacement of the 16 inch thick concrete pavement and all pavement layers underneath. This contract also includes airfield electrical and drainage improvements.

Solicitation
 This Project was advertised in accordance with the City's requirements.

Human Relations Approval
 Contract information was submitted to the Aviation Department's DBE Program Manager for review and determination. See docket memo attached. The DBE approved goals are 18% and the approved DBE subcontractors are as follows: Clymore Trucking Co., Inc.; R.L. Hannah & Sons Trucking, Inc., Pine Valley Contracting, Inc., Petro Logistics, LLC.
