Executive Summary

Authorizing a \$1,481,880.00 contract with MegaKC for the Rehabilitate Relief Wells (Phase IV) project at CBW Downtown Airport; authorizing a maximum expenditure of \$1,630,068.00.

Discussion

THE MWDBE CREO CUP WAS APPROVED FOR 10% MBE AND 10% WBE PARTICIPATION.

The Missouri River Levee System and associated control facilities consisting of a complex system of water meters, relief wells and a collector system protect the airport from flooding and must be maintained on a regular basis.

The intent of the project is to replace four (4) relief wells (RW) (32A, 33A, 34A and 36A) and pump test an additional seven (7) RW (2A, 5A, 11A, 14A, 22A, 27A and 31A) at the Kansas City Wheeler Downtown Airport (MKC).
