Authorizing a \$4,730,592.00 contract with Ideker, Inc. for the Overhaul Base Apron Rehab – Phase 2 project at KCI Airport; authorizing an expenditure of \$5,676,710.40.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Aviation is hereby authorized to execute a contract with Ideker, Inc. for construction services for Project No. 62210547– Overhaul Base Apron Rehab – Phase 2 for \$4,730,592.00 from funds previously appropriated to Account No. 23 – 8300 - 627270-62210547 - B. A copy of the contract is on file in the Aviation Department.

Section 2. That the Director of Aviation is hereby authorized to amend and increase this contract by a contingency of \$946,118.40.
