**Status**: Projects 2a, 2b, and 2c were actually developed as an Urban Garden instead of the commercial, condominiums/retail/office and related parking. The Developers completed the rehabilitation of Project 12 (office building), Project 17 (retail establishment), Project 18 (office building), and related parking lots. A number of the other proposed projects were ultimately done as Planned Industrial Expansion Authority projects instead of TIF assisted projects.






