REGULATION NUMBERS 66850 THROUGH 66866 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the “Code of General Ordinances of Kansas City, Missouri” and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

<u>Regulation Number</u>	<u>Location</u>	<u>Direction of Restriction</u>
66850	N Bales Avenue and NE 89 th Street	Northbound and Southbound
66851	Chestnut Avenue and Hagerwood Road	Northwestbound
66852	Locust Street and Santa Fe Trail	Southbound

The driver of a vehicle shall **Yield The Right of Way** to all vehicles approaching the following intersection(s) (in the direction bound as indicated) when Yields are in place, and shall be added to the list as contained in **Section 70-335**:

66853	N Bristol Avenue and NE 51 st Street	Westbound
66854	Cherry Street and 78 th Terrace	Eastbound

66855	N Fremont Avenue and NE 50 th Street	Eastbound
66856	Locust Street and 62 nd Street	Southbound
66857	N Revere Avenue and NW 58 th Street	Eastbound and Westbound

The **Maximum School Speed Limit**, as indicated below and as listed in **Section 70-363**, is hereby discontinued at the following location(s):

66858	NW Barry Road, from N Congress Avenue to a point 425 feet east of N Conant Avenue	25 Miles Per Hour From 6:30 AM to 8:30 AM and 1:30 PM to 3:30 PM Monday Through Friday

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

66859	48 th Street, south side, from a point 140 feet west of Jefferson Street then west 85 feet	No Parking Anytime
66860	74 th Street, north side, from Wornall Road to Broadway	No Parking Anytime
66861	Locust Avenue, east side, from Gillham Road then north 350 feet	No Parking 7:00 AM to 6:00 PM Monday through Friday
66862	Vine Street, west side, from 19 th Street then south 600 feet	No Parking Anytime
66863	Woodland Avenue, east side, from Truman Road to 15 th Terrace	No Parking Anytime
66864	Woodswether Road, north side, from Madison Avenue to Mulberry Street	No Parking Anytime

66865	Woodswether Road, south side, from Madison Avenue to Mulberry Street	No Parking Anytime

Parking for longer than the **Time Limit**, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in **Section 70-531**:

66866	74 th Street, north side, from Broadway to Wyandotte Street	Fifteen Minute Parking 7:00 AM to 7:00 PM Monday through Friday

The locations affected by the above regulations will be marked in accordance with standards prescribed in the “Manual on Uniform Traffic Control Devices for Streets and Highways” and said regulations shall become effective five days after publication in The Daily Record.
