Pursuant to Section 67.1451.4(3), RSMo, your office is responsible for (i) disbursing the Declaration of Candidacy to any prospective candidate, (ii) collecting completed Declarations of Candidacy from prospective candidates, and (iii) collecting a Five Dollar (\$5.00) filing fee from each prospective candidate. As stated in the Notice, and pursuant to Section 115.127.5, RSMo, candidates may submit the Declaration of Candidacy to your office beginning at 8:00 a.m. on March 31, 2026 and ending at 5:00 p.m. on April 28, 2026. As permitted in Section 115.124.1 RSMo, if the total number of candidates equals the number of positions to be filled, the District may forego a mail-in ballot election.
