REGULATION NUMBERS 67179 THROUGH 67192 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the “Code of General Ordinances of Kansas City, Missouri” and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

67179	N Amoret Avenue and NW 95 th Terrace	Westbound
67180	N Ditzler Avenue and NE 115 th Terrace	Northbound
67181	Overton Avenue and 51 st Terrace	Westbound
67182	N Revere Avenue and NW 58th Street	Eastbound and Westbound
67183	N Tullis Avenue and NE 105 th Street	Southbound
67184	N Willow Avenue and NE 100 th Terrace	Northbound

The driver of a vehicle shall **Yield The Right of Way** to all vehicles approaching the following intersection(s) (in the direction bound as indicated) when Yields are in place, and shall be added to the list as contained in **Section 70-335**:

<u>Regulation Number</u>	<u>Location</u>	<u>Direction of Restriction</u>
67185	NE Barnes Avenue and NE 52 nd Street	Westbound
67186	Cherry Street and 91 st Street	Northbound
67187	NE Gunn Avenue, N Topping Avenue, and NE 52 nd Street	Eastbound
67188	N Hunter Avenue and NE 101 st Street	Northbound

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

<u>Regulation Number</u>	<u>Location</u>	<u>Restriction</u>
67189	DeGroff Way, east side, from 30 th Street to 31 st Street	No Parking Anytime
67190	Hocker Road, east side, from US 40 to 49 th Street	No Parking Anytime
67191	Locust Avenue, east side, from 38 th Street to Gillham Road	No Parking 7:00 AM to 6:00 PM Monday through Friday

Reserved parking for **Physically Disabled Persons** is hereby established, as indicated below, and shall be added to the lists as contained in **Sections 70-534** and **70-535**:

<u>Regulation Number</u>	<u>Location</u>	<u>Restriction</u>
67192	Askew Avenue, west side, from a point 370 feet south of 25th Street then south 22 feet	Accessible Parking

The locations affected by the above regulations will be marked in accordance with standards prescribed in the “Manual on Uniform Traffic Control Devices for Streets and Highways” and said regulations shall become effective five days after publication in The Daily Record.
