Dear Ms. Sanders:

In accordance with Section 67.1471, RSMo, notice is hereby provided of the anticipated annual budget for the period of May 1, 2024 to April 30, 2025 of the Zona Rosa Community Improvement District. This is a supplement to my letter to you dated January 8, 2024. The rate of assessment of the District is a special assessment based upon the square foot of real property within the District not to exceed \$1.89 per square foot. The total of the maximum special assessments for properties on an annual basis within the District is \$1,131,192.22 (this represents the maximum amount for each individual property as follows: Parcel ID 20-1.0-12-100-001-005.000).

On September 25, 2023, the District adopted Resolution 2023:01 to levy a special assessment in the amount of \$365,618.00 for the sole tax parcel in the District. The District expended these revenues in the 2023-2024 fiscal year as follows: 1) payment of 1% collection fee by Platte County: 2) payment of \$17,500 to Calculation Agent per the bond documents; and 3) payment of the remainder for debt service payable on the \$7,035,000 Transportation Refunding Revenue Bonds (Zona Rosa Phase II Retail Project) Series 2016 of The Industrial Development Authority of the County of Platte County, MO. The proposed budget for fiscal year 5/1/24-4/30/25 will expend the revenues in the same manner as set forth above and as required by the bond documents.

For the 2024 tax year, the actual amount of special assessments/anticipated revenue will not be known until such time as the Calculation Agent makes the calculation of the special assessment to be levied. The revenue will be used for the purposes of payment of the debt service payable on the \$7,035,000 Transportation Refunding Revenue Bonds (Zona Rosa Phase II Retail Project) Series 2016 of The Industrial Development Authority of the County of Platte County, Missouri for construction of City Transportation Projects within the District, Calculation Agent fee, and a payment to Platte County for collection of the special assessments.

WHEREAS, pursuant to Resolution 08-002 adopted by the Board of Directors ("Board") on May 27, 2008 ("Resolution"), the Board acknowledged receipt of Petition signed by property owners within District and authorized levying the special assessments in maximum amount of \$1.89 per sq. ft. and authorized its Calculation Agent to calculate special assessment subject to formula set forth in the Resolution on an annual basis; and

WHEREAS, pursuant to the Resolution, the Calculation Agent has made the required calculations and informed the District of the specific 2023 Special Assessment amounts to be collected; and

WHEREAS, the Board desires to levy the specific amount for the 2023 special assessment and inform Platte County Collector ("County Collector") of 2023 Special Assessment to be collected pursuant to District's Cooperative Agreement with County for collection of special assessment;

THEREFORE, BE IT RESOLVED THAT, pursuant to the Resolution which acknowledged the Petition received from property owners authorizing the levying of special assessments, the Board hereby approves the calculation and levying of 2023 Special Assessments for District as follows and directs the County Collector be notified of the 2023 Special Assessment amount as set forth below:
