- This situation is unprecedented. Nowhere else around the Plaza does an R-6 zone immediately abut an R-.75 district with much more intense density and height.
- City officials are ignoring the Midtown Plaza Area Plan and the City's Municipal Code Criteria in order to recommend rezoning.
- Once approved for rezoning, the developer is not bound by the depiction it presented; they could change the construction plan at will, without any need for public engagement.
- Rezoning establishes a new precedent for increased height and density next to other smaller homes.
