## REGULATION NUMBERS 62861 THROUGH 62871 INSTALLATIONS

## TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

Regulation Number	Location	<b>Direction of Restriction</b>
62861	Chestnut Avenue and 80th Street	Northbound
62862	McGee Street and 10th Street	Northbound and Southbound
62863	North Seymour Avenue, Northwest 89th Terrace and Northwest 90th Street	Northbound and Southbound
62864	Ward Parkway and 60th Terrace (Median)	Eastbound and Westbound
62865	Ward Parkway and 61st Street (Median)	Eastbound and Westbound

<u>Turns</u> are prohibited, as indicated, at the following location(s) (in the direction bound as indicated) and shall be added to the list as contained in <u>Section 70-457</u>:

Regulation Number	Location	Turn Restriction
62866	Charlotte Street and 10th Street	Northbound Trucks No Right Turn

**Stopping, Standing and/or Parking** shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

Regulation Number	Location	Restriction
62867	34th Terrace, north side, from Gillham Road to Warwick Boulevard	No Parking Anytime
62868	38th Street, north side, from Jarboe Street west 45 feet	No Parking Anytime
62869	Oak Street, west side, from 63rd Street south to a point 45 feet north of Meyer Boulevard	No Parking Anytime
62870	Warwick Boulevard, west side, from 34th Terrace to Armour Boulevard	No Parking Anytime

<u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in <u>Section 70-531</u>:

Number Number	Location	Restriction
62871	Truman Road (North Drive), north side, from a point 55 feet west of Grand Boulevard then west 182 feet	Two Hour Parking

The locations affected by the above regulations will be marked in accordance with standards prescribed in the "Manual on Uniform Traffic Control Devices for Streets and Highways" and said regulations shall become effective five days after publication in The Daily Record.
