#### **Executive Summary**

Authorizing the Director of Convention and Entertainment Facilities to execute a \$2,000,825.00 contract with Schindler Elevator Corporation for ADA elevator modifications at the Kansas City Convention Center for the Exhibit Hall Elevator Project; authorizing a maximum expenditure of \$2,401,000.00; and recognizing this ordinance as having an accelerated effective date.

#### **Discussion**

The purpose of this project is to complete the last of the ADA compliance and modernization projects in the Convention Center complex. It modernizes five of ten elevator cars to various levels of need. The remaining five will have upgrades, including Code and ADA compliance corrections, interior finishes, and lighting improvements. The selected contractor has pledged to exceed the M/WBE participation goals of 10%/10% by proposing a 40%/40% contribution.
