Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The <u>Maximum Speed Limit</u>, as indicated below and as listed in <u>Section 70-363</u> is hereby discontinued at the following location(s):
