# MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION SUPPLEMENTAL COST SHARE AGREEMENT #1

THIS SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and City of Kansas City, Missouri (hereinafter, "Entity").

#### WITNESSETH:

WHEREAS, on March 30, 2018, the Commission and the City previously entered into a Cost Share Agreement as to public improvements designated as the US 169/Buck O'Neil Bridge, (hereinafter, "Original Agreement"); and

WHEREAS, the Commission and the Entity now desire to revise the Original Agreement as provided in this Supplemental Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained herein, the parties agree as follows:

- (1) <u>REVISION</u>: Paragraph (9) of the Original Agreement is hereby removed and replaced with the following:
- (9) <u>FINANCIAL RESPONSIBILITIES</u>: The current estimated cost of the public improvements are as follows:

**J4S3085B** – Four million eight hundred thousand dollars (\$4,800,000) construction contract amount

**J4S3085** – One million eight hundred, eighty-three thousand, three hundred and forty-six dollars and eighty-four cents (\$1,883,346.84) consultant contract amount for NEPA work.

The Commission's maximum cost share funds available for these projects is three million one hundred eighty five thousand dollars (\$3,185,000), with the source for the remainder of the funds from the KC District STIP funds.

The Responsibility Summary outlines the project costs and responsibilities and is

attached hereto as "**Exhibit B**," and incorporated herein. With regard to work under this Agreement, the Entity agrees as follows:

## **J4S3085B** – Short term rehabilitation of the Bridge

- (A) The Entity will be responsible for fifty percent (50%) of the total project cost as outlined in Exhibit B. The total project cost will only include the construction contract cost for J4S3085B. The current estimate for project J4S3085B is four million eight hundred thousand dollars (\$4,800,000). The current estimate of the Entity's responsibilities is two million four hundred thousand dollars (\$2,400,000).
- (B) The amount the Entity owes the Commission for this project is two million four hundred thousand dollars (\$2,400,000) and that amount will be deducted from the amount the Commission owes the Entity of seven million five hundred thousand dollars (\$7,500,000) for the project J4I1710 "Cooperative Agreement Bartle Hall Expansion Phase II" and listed in the STIP as J4P2316 "Budget Transfer" to the Entity. . If project costs exhaust the remaining funds in J4P2316, the Entity will be responsible for depositing additional funds with the Commission to cover the expenses. This check should be made payable to Director of Revenue Credit State Road Fund. If the Entity fails to make the deposit, the Commission is under no obligation to continue with the project.
- (C) Over/Under –runs shall be handled based on the Commission and Entity's pro rata share of the investment as outlined in this agreement.
- (E) The Commission will be responsible for the internal MoDOT staff costs at no cost or expense to the Entity. The Entity will be responsible for the internal Entity's staff costs at no cost or expense to the Commission.

### **J4S3085** – NEPA work EA for the rehabilitation or replacement of the Bridge

- (F) The Entity will be responsible for fifty percent (50%) of the total project cost for the NEPA work. The total project cost will only include consultant contract amount for this work. The current estimate for project J4S3085 NEPA work is One million eight hundred, eighty-three thousand, three hundred and forty-six dollars and eighty-four cents (\$1,883,346.84). The current estimate of the Entity's responsibilities is nine hundred, forty-one thousand, six hundred and seventy-three dollars and forty-two cents. (\$941,673.42).
- (G) The amount owed to the Commission for this project (\$941,673.42) will be deducted from the amount the Commission owes the Entity (\$7,500,000) for the project J4I1710 "Cooperative Agreement Bartle Hall Expansion Phase II" and listed in the STIP as J4P2316 "budget Transfer" to the Entity. If project costs exhaust the remaining funds in J4P2316, the Entity will be responsible for depositing additional funds with the Commission to cover the expenses. This check should be made payable to Director of Revenue Credit State Road Fund. If the Entity fails to make the deposit, the

Commission is under no obligation to continue with the project.

- (H) Over/Under –runs shall be handled based on the Commission and Entity's pro rata share of the investment as outlined in this agreement
- (I) The Commission will be responsible for the internal MoDOT staff costs at no cost or expense to the Entity. The Entity will be responsible for the internal Entity's staff costs at no cost or expense to the Commission.
- (2) ORIGINAL AGREEMENT: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement between the parties shall remain in full force and effect and shall extend and apply to this Supplemental Agreement as if fully written in this Supplemental Agreement.
