

ORDINANCE NO. 201003

Estimating revenue in the amount of \$950,000.00 in the Platte County Special Assessment for roads and bridges account in the Capital Improvement Sales Tax fund; and appropriating \$3,072,027.62 to the Green Hills Road Project account in the Capital Improvement Fund; and recognizing an accelerated effective date.

WHEREAS, Resolution No. 170768 dedicated but did not estimate or appropriate the calendar year collections for calendar years 2016 through 2019 to Green Hills Road; calendar year collections are received in the following fiscal year, and

WHEREAS, revenue committed, but not appropriated to a specific contract were recorded as Fund Balance in the Capital Improvements sales tax fund; and

WHEREAS, Ordinance No. 180926 estimated and appropriated contributions from the Platte County Special Assessment to Green Hills Road and estimates, appropriations, and previously collected special assessment revenues require trueing-up in Fiscal Year 2020; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That revenue in the following accounts in the Capital Improvements Sales Tax Fund is hereby estimated in the following amount:


Section 3. That the Director of Public Works is designated as requisitioning authority for Account No. 21-3090-895802-B-611060-89008087.
