REGULATION NUMBERS 62878 THROUGH 62901 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

62878	North Cypress Avenue and Northeast 60th Terrace	Northbound
62879	North Lawn Avenue and Northeast 101st Street	Northbound and Southbound
62880	The Paseo and 57th Street (Median)	Eastbound and Westbound
62881	North Quincy Avenue and Northeast 63rd Street	Southbound

The following street(s) is (are) designated for a **Maximum Speed Limit** as indicated and shall be added to the list as contained in **Section 70- 363:**

<u>Regulation Number</u>	<u>Location</u>	<u>Maximum Speed Limit</u>
62882	Northeast 96th Street, from Northeast Shoal Creek Parkway to North Flintlock Road	Forty Miles Per Hour
62883	Cherry Street, from 25th Street to 27th Street	Twenty Five Miles Per Hour
62884	Northeast Shoal Creek Parkway, from I-435 Highway to Northeast 96th Street	Forty Five Miles Per Hour

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530:**

62885	10th Street, south side, from Central Street east 35 feet	No Parking Anytime
62886	10th Street, south side, from a point 128 feet east of Central Street then east 39 feet	No Parking Anytime

62888	43rd Street, north side, from Clark Avenue west 42 feet	No Parking Anytime
62889	North Agnes Avenue, west side, from a point 283 feet north of Maplewoods Parkway south to Gladstone, Missouri City Limits	No Parking Anytime
62890	Central Street, east side, from a point 203 feet north of 11th Street then north 33 feet	No Parking Anytime
62891	Central Street, east side, from a point 441 feet north of 11th Street then north 18 feet to 10th Street	No Parking Anytime
62892	Clark Avenue, west side, from 43rd Street north 40 feet	No Parking Anytime

62893	Pennsylvania Avenue, east side, from a point 210 feet north of 46th Street then north 70 feet	No Parking Anytime
62894	Southwest Boulevard, south side, from a point 103 feet east of 24th Street then east 58 feet	No Parking Anytime
62895	Southwest Boulevard, south side, from a point 203 feet east of 24th Street then east 16 feet	No Parking Anytime

Parking for longer than the **Time Limit**, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in **Section 70-531**:

62896	Southwest Boulevard, south side, from a point 27 feet east of 24th Street then east 76 feet	One Hour Parking 7:00 AM to 6:00 PM Monday through Saturday
62897	Southwest Boulevard, south side, from a point 161 feet east of 24th Street then east 42 feet	Three Hour Parking 7:00 AM to 6:00 PM Monday through Saturday
62898	Southwest Boulevard, south side, from a point 219 feet east of 24th Street then east 76 feet	Three Hour Parking 7:00 AM to 6:00 PM Monday through Saturday

Reserved Parking for **Physically Disabled Persons** is hereby established, as indicated below, and shall be added to the lists as contained in **Sections 70-534 and 70-535**:

62899	Highland Avenue, east side, from a point 186 feet north of 38th Street then north 24 feet	Accessible Parking

A **Loading Zone** is designated at the following locations, and shall be added to the list as contained in **Section 70-561:**

62900	10th Street, south side, from a point 35 feet east of Central Street then east 93 feet	No Parking Passenger Loading Zone
62901	Central Street, east side, from a point 236 feet north of 11th Street then north 205 feet	No Parking Passenger Loading Zone

The locations affected by the above regulations will be marked in accordance with standards prescribed in the “Manual on Uniform Traffic Control Devices for Streets and Highways” and said regulations shall become effective five days after publication in The Daily Record.
