Authorizing the Director of General Services to expend \$149,000.00 for security services at the Historic 18th and Vine Jazz District and the Black Archives of Mid-America Kansas City; authorizing the Manager of Procurement Services to execute a \$82,000.00 contract with Reclaiming Our Community, a Missouri Nonprofit Corporation, to provide community COVID assistance programs; and appropriating the sum of \$231,000.00 from the Unappropriated Fund Balance of the General Fund for the purposes.

WHEREAS, the American Rescue Plan Act, which was signed into law by the President of the United States on March 11, 2021, provides for a State and Local Coronavirus Relief Fund that appropriates \$325 billion to States and units of Local Government to cover costs related to, and address the negative economic impacts associated with, the COVID-19 pandemic; and

WHEREAS, the Kansas City's stimulus spending plan, "RecoverKC", was finalized and adopted by the City Council on May 27, 2021 to establish the costs, uses, and programming for which the City's stimulus funds are purposed, and the RecoverKC plan provided much needed financial relief to the City; and

WHEREAS, the historic 18th and Vine Jazz District and the Black Archives of Mid-America Kansas City are among the City's historical assets and currently without a security presence; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of General Services is authorized to expend \$149,000.00 for security services at Black Archives of Mid-America Kansas City and the Historic 18th and Vine Jazz District.

Section 2. That the sum of \$149,000.00 is appropriated from the Unappropriated Fund Balance of the General Fund to the following account:

ORDINANCE NO. 210585

Amending Chapter 2, Code of Ordinances, by repealing Sections 2-964, entitled Commission established; membership; officers, and 2-965 entitled Duties of commission, and enacting in lieu thereof new sections of like numbers and subject matter.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 2, Code of Ordinances of the City of Kansas City, Missouri, is hereby amended by repealing Sections 2-964, entitled Commission established; membership; officers, and 2-965, entitled Commission established; membership; officers, and enacting in lieu thereof new sections, to read as follows:

Sec. 2-964. Commission established; membership; officers.

There is hereby created and established a commission to be known as the Brownfields Commission. The commission shall be composed of 15 members. Eight of those commissioners shall be residents of the city, appointed by the mayor to serve four-year terms, further delineated as follows: three representing citizen and community groups; one representing regional environmental justice communities; one with expertise in the field of business; one with expertise in the field of real estate development; one with expertise in the field of environmental assessment and remediation; and one being a lawyer member of the Missouri Bar Association with expertise in environmental law. Three additional commissioners shall be the mayor, chairman of the city plan commission and chairman of the board of directors of the economic development corporation of Kansas City, or their designees, who shall be ex officio members of the commission. Four regional commissioners shall be the chief executive of Jackson County, Missouri; the mayor of the Unified Government of Wyandotte County/Kansas City, Kansas; the chief executive of the Mid-America Regional Council; and the chief executive of the Kansas City Area Development Council, or their designees, who shall be ex officio members of the commission representing governments and non-profit entities in partnership with the city for brownfields redevelopment. The members of the commission shall serve without compensation and those appointed by the mayor shall be subject to removal by the mayor. The mayor shall designate one of the commissioners as chairperson of the commission and another as vice-chairperson. The director of Brownfields shall be the secretary and provide administrative support for the commission.

Sec. 2-965. Duties of commission.

- (a) The duties of the Brownfields Commission shall be to promote the cleanup and reuse of brownfield properties in order to create jobs, increase the tax base, remove potential threats to public health and the environment, or otherwise productively reuse idle, abandoned or underutilized properties. When conducting business concerning primarily the city or the Kansas City Brownfields Revolving Loan Fund, the commission, excluding the four regional commissioners, shall:
 - (1) consider applications for loans and subgrants of funds from the Kansas City Brownfields Revolving Loan Fund, vote on resolutions to approve applications for assistance of \$100,000 or

less, and vote on resolutions to recommend to the city council approval of applications for assistance over \$100,000;

- (2) consider requests for city endorsement of applications to the Missouri Brownfields Redevelopment Program or other state or federal Brownfields Assistance Program, and vote on resolutions to recommend endorsement to the city council; and
- (3) conduct such other business of the city as necessary to provide guidance and policy recommendations concerning the promotion of brownfields redevelopment, in partnership with federal, state and regional and local entities.
- (b) When conducting business concerning the Kansas City Regional Coalition Brownfields Revolving Loan Fund, the commission, excluding the three commissioners who are Kansas City, Missouri residents representing citizen and community groups, and the chairman of the board of directors of the economic development corporation of Kansas City, shall:
 - (1) consider applications for loans and subgrants of funds from the Kansas City Regional Coalition Brownfields Revolving Loan Fund and vote on resolutions to approve applications for assistance of \$100,000.00 or less, and vote on resolutions to recommend to the city council approval of applications for assistance over \$100,000.00; and
 - (2) conduct such other business of the regional brownfields coalition as necessary to provide guidance and policy recommendations concerning the promotion of brownfields redevelopment, in partnership with federal, state and regional and local entities. In providing such assistance, approval or confirmation, the commission, commissioners, city and regional municipal partners do not assume any responsibility or liability for any risks or costs associated with any such environmental impairment identification or management activities.

Reason For Legislation

Amending Chapter 2 of the Code of Ordinances by repealing Section 2-964, entitled Commission established; membership; officers, and by repealing Section 2-965 entitled Duties of commission, and enacting in lieu thereof new sections of like numbers.

Discussion

This ordinance will amend Section 2-964 of Chapter 2 of the Code of Ordinances to add representatives of Jackson County, Missouri; the Unified Government of Wyandotte County/ Kansas City, Kansas; Kansas City Area Development Council; and, Mid-America Regional Council to the brownfelds commission, and replace one four existing representatives of citizen and community groups with an environmental justice commissioner. It also amends Section 2-965 to update the duties of the commission and its business procedures. The amendments will enable the commission to implement the Kansas City Regional Coalition Brownfields Revolving Loan Fund Grant awarded by EPA, Ordinance No. 200610 and continue its current business.

Amending Chapter 2, Code of Ordinances, by repealing Sections 2-964, entitled Commission established; membership; officers, and 2-965 entitled Duties of commission, and enacting in lieu thereof new sections of like numbers and subject matter.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 2, Code of Ordinances of the City of Kansas City, Missouri, is hereby amended by repealing Sections 2-964, entitled Commission established; membership; officers, and 2-965, entitled Commission established; membership; officers, and enacting in lieu thereof new sections, to read as follows:

Sec. 2-964. Commission established; membership; officers.

Eight of those commissioners shall be residents of the city, appointed by the mayor to serve four-year terms, further delineated as follows: fourthree representing citizen and community groups; one representing regional environmental justice communities; one with expertise in the fieldsfield of business; one with expertise in the field of real estate development, and; one with expertise in the field of environmental assessment and remediation; and one being a lawyer member of the Missouri Bar Association with expertise in environmental law. The other three Three additional commissioners shall be the mayor, chairman of the city plan commission and chairman of the board of directors of the economic development corporation of Kansas City, or their designees, who shall be ex officio members of the commission. The members of the commission shall serve without compensation and Four regional commissioners shall be the chief executive of Jackson County, Missouri; the mayor of the Unified Government of Wyandotte County/Kansas City, Kansas; the chief executive of the Mid-America Regional Council; and the chief executive of the Kansas City Area Development Council, or their designees, who shall be ex officio members of the commission representing governments and non-profit entities in partnership with the city for brownfields redevelopment. The members of the commission shall serve without compensation and those appointed by the mayor shall be subject to removal by the mayor. The mayor shall designate one of the commissioners as chairperson of the commission and another as vicechairperson. The director of Brownfields shall be the secretary and provide administrative support for the commission.

Sec. 2-965. Duties of commission.

(a) The duties of the Brownfields Commission shall be to identifypromote the cleanup and manage environmental risks and costs associated with the reuse of urbanbrownfield properties so that such factors do not impede important redevelopment projects that in order to

ORDINANCE NO. 210502

Amending Chapter 2, Code of Ordinances, by amending Sections 2-367, 2-1111, 2-1112, 2-1113, and 2-1114 to authorize the director of human resources to take disciplinary action when the city's equal employment opportunity policy is violated, to change the members of the EEO review committee, and to provide regular employees subject to various discipline and suspension pending completion of an investigation a predetermination hearing.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 2, Code of Ordinances, entitled "Administration," is hereby amended by repealing Sections 2-367, 2-1111, 2-1112, 2-1113, and 2-1114 and enacting in lieu thereof a new section of like number and subject matter to read as follows:

Sec. 2-367. Complaints.

- (a) The office of equal employment opportunity/diversity will oversee and keep records on the enforcement of the city's EEO policy.
- (b) Any employee who alleges that he or she is being treated unfairly because of his or her race, religion, color, ancestry, sex, (including pregnancy), national origin, age (over 40), disability, marital status, genetic information, gender identity, or sexual orientation, or who alleges that another person has otherwise violated the city's EEO policy may file a written complaint with the office of equal employment opportunity/diversity on forms provided by the office which shall set forth the particulars thereof and any such other information that may be required by the EEO office.
- (c) Employees are urged to promptly report violations of the city's EEO policy. Complaints of violations of the city's EEO policy shall be filed no later than 180 days from the last act of prohibited conduct. Any supervisory employee who receives a complaint or who observes or otherwise becomes aware of any such conduct shall promptly report it to the EEO office.
- (d) During the period beginning with the filing of such complaint, the office of equal opportunity/diversity may recommend conciliation/mediation to seek to resolve the complaint.
- (e) Investigations of complaints of an alleged violation of the EEO policy. Upon receiving a complaint or report, the human resources director shall immediately take whatever action is necessary to protect the person making the complaint from any continued or additional inappropriate conduct. The EEO office will conduct an initial inquiry into the complaint to determine if the complaint warrants further investigation. If further investigation is required, the EEO office will investigate the complaint or assist the department from which the complaint came to investigate the complaint, if appropriate. Those assigned to investigate complaints will prepare a finding of facts and present these findings to a committee made up of the director of human resources or designee, assistant city manager and chief equity officer or city manager designee. This committee will review the findings of fact and issue a

determination. If it is found that a violation of the harassment policies has occurred, the committee will recommend corrective or disciplinary action to the human resources director in an effort to end or to prevent the recurrence of any harassment. The human resources director shall not enact corrective or disciplinary measures that would conflict with the committee recommendation without city manager approval.

(f) Complaints to outside agencies. City employees may make any complaints of discrimination and harassment to the Equal Employment Opportunity Commission or the Missouri Commission on Human Rights in accordance with the procedures and limitations applicable to those agencies. In the event an employee files a complaint alleging the same act or practice with an outside agency, the EEO office shall continue its investigation. In the event an employee elects to file a complaint only with an outside agency, the EEO office shall allow the outside agency to conduct the investigation.

Sec. 2-1111. Reprimands.

Except as otherwise provided in this code, a department head may reprimand any employee for cause. Such reprimand shall be in writing and addressed to the employee. A signed copy shall be delivered to the human resources department for inclusion in the employee's personnel file. Reprimands may not be appealed to the human resources board. However, the employee may file a letter to respond to the reprimand which shall be attached to the reprimand in his personnel file.

Sec. 2-1112. Suspension.

- (a) Generally. Except as otherwise provided in this code, a department head may for cause issue to an employee a disciplinary suspension without pay for a period or periods not exceeding 30 calendar days in any 12 months; however, no single suspension shall be for more than 15 calendar days. The department head shall notify the employee concerned and the director of human resources in writing not later than one day after the date the suspension is made effective. Such notice shall include the reasons for and the duration of the suspension. Any permanent employee who is suspended may appeal for a hearing in writing to the human resources board within ten calendar days of notice of suspension.
- (b) Suspension pending investigation/predetermination hearing. In order to protect the city's interests, a department head may remove an employee from the workplace and place the employee on suspension without pay pending the completion of an internal investigation or predetermination hearing. Such suspensions shall not be the normal course of business and should be utilized only when necessary to prevent the destruction of evidence/property, protect citizens or employees from harm/intimidation, or to protect the public's interest and confidence in city government. The department head shall notify the employee concerned and the director of human resources in writing not later than one day after the date the suspension is made effective. Such notice shall include the reasons for and the anticipated duration of the suspension. No suspension pending an investigation shall exceed 15 calendar days without prior approval from the city manager. Any permanent employee who is suspended pending an investigation will be provided a predetermination hearing as authorized by this code and may appeal for a hearing in writing to the human resources board within ten calendar days of the predetermination hearing answer. Permanent employees placed on suspension pending an investigation may also, at their request, utilize their free day, and/or accrued vacation and compensatory leave time. If the investigation finds that a suspension or the length of the suspension was not warranted, the employee shall be entitled to receive full back-pay.
- (c) Effect of arrest or conviction. Any employee who is arrested for a felony or Missouri class A misdemeanor charge or its equivalent or an ordinance or statutory violation alleging bodily harm or threat thereof, and has a trial pending shall have his case reviewed by the department head or designee. It is the employee's responsibility to notify his or her department head of such charges. The department head, or designee, taking into consideration the duties and service of the employee, shall have the authority to reassign the employee to a less sensitive position or to suspend the employee until such time as a judgment is rendered by the court. If the employee either pleads guilty, no

contest or the equivalent, or is subsequently convicted of a felony or Missouri class A misdemeanor charge or its equivalent or an ordinance or statutory violation involving bodily harm or threat thereof, including but not limited to a reduced charge as a result of a plea bargain, he or she may be removed from the municipal service. If the suspended employee is found not guilty and is released by the court, he or she shall be reinstated to the former position with pay upon the employee's furnishing the department head, or designee, proper documentation regarding other employment, if any, for all time he was suspended as a result of such charges. However, any earnings of a suspended employee from another employer during the period of suspension shall be offset against the back pay with the city. It is the employee's responsibility to keep his or her department head aware of any pending charges, and the outcome of the charges against him or her.

Sec. 2-1113. Demotion.

Except as otherwise provided in this code, a department head may demote any employee for cause. A written statement of the reasons for any such action shall be furnished to the employee and a copy filed with the director of human resources at least seven (7) calendar days prior to the effective date of the action. No demotion shall be made as a disciplinary action unless the employee to be demoted is eligible for employment in the lower class. Any regular employee who is demoted shall receive a predetermination hearing and as provided in this code may appeal for a hearing in writing to the human resources board within ten days of receipt of written notice of such action.

Sec. 2-1114. Dismissal.

- (a) *Generally*. Except as otherwise provided in this code, a department head may dismiss for cause any regular employee under his jurisdiction by delivering, at least seven (7) calendar days before the effective date thereof, a written statement of reasons to the employee concerned and to the director of human resources.
- (b) Suspension pending discharge. If the department head, because of the reasons for the discharge, desires to make an immediate separation from the service, he may make a suspension without pay pending discharge by so notifying the director of human resources in writing of the recommendation and the reasons therefore. Suspensions pending discharge shall not be subject to the limitations of suspension length provided in other sections of this article.
- (c) *Appeal*. Any regular employee so dismissed shall receive a predetermination hearing and have the right to appeal in writing within ten days of the dismissal to the human resources board and shall be granted a hearing as provided for in section 907 of the Charter.

WHEREAS, the City must commission a Disparity Study in support of its MWDBE Program prior to December 1, 2022; and

WHEREAS, compiling information on veteran-owned and LGBTQ-owned businesses will be helpful in determining whether a disparity exists for those businesses in receiving local government contracts; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is directed to develop a registry of veteran-owned and LGBTQ-owned businesses by coordinating with organizations including the U.S. Department of Veterans Affairs and the Mid-America LGBT Chamber of Commerce.

Section 2. That the City Manager is directed to include a disparity analysis of veteran-owned and LGBTQ-owned businesses, along with other businesses whose owners may face discrimination in the local marketplace, in the next Disparity Study to be used in support of the City's MBE/WBE Program.

COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 210445

Authorizing the City Manager to enter into contracts with Merging KC, Inc. for construction and associated services of Verge--A Pallet Community, that will consist of temporary shelters for approximately 200 beds and related offices for security, medial and other services; appropriating \$1,700,000.00 from the Unappropriated Fund Balance of the General Fund; designating requisitioning authority; approving a substantial amendment to the 2020 One Year Action Plan to reprogram funding; recognizing this ordinance as having an accelerated effective date; and waiving the solicitation requirements of Chapter 3.

WHEREAS, Kansas City is the hometown to as many as 1700 people in the houseless community, according to Project Homeless Connect Kansas City, with 370 people under the age of 18; and

WHEREAS, the COVID-19 pandemic exacerbated the public health issue by exponentially increasing job loss and financial struggle, particularly in communities of color and for those living at or near the poverty threshold as established by the United States' Department of Health and Human Services; and

WHEREAS, the intersecting and sometimes competing costs of housing and health create an undue burden on our city's poorest and most vulnerable residents; and

WHEREAS, spending public dollars to mitigate the effects of houselessness on the entire community serves a legitimate public purpose; and

WHEREAS, in accordance with Resolution No. 210316 the City Manager has identified ways to extend and expand hotel, motel, and other livable spaces arrangements for unhoused persons in Kansas City; and

WHEREAS, the Council acknowledges this agreement is meant to serve as a transitional housing community with a goal of preparing clients for long-term permanent housing; and

WHEREAS, through Ordinance No. 210392 adopting the City's stimulus spending plan, *RecoverKC*, the City Council authorized \$800,000.00 of the City's American Rescue Plan - Local Fiscal Recovery Funds be used for these purposes; and

WHEREAS, Verge will include coordination of services such as hot meals, caseworkers, food and clothing, dental services, haircuts, mental health and other health needs and on-site classes that may cover money management, cleaning, cooking, laundry and other life skills; and

WHEREAS, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was passed by Congress and signed into law by the President on March 27, 2020, to make available supplemental funding for

the Emergency Solutions Grant (ESG-CV) to prevent, prepare for and respond to the coronavirus pandemic, to assist eligible communities and households economically impacted by COVID-19 and to mitigate its impact; and

WHEREAS, execution of contracts will provide needed outreach, case management, shelter operations and including the purchase of pallets to house the houseless; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is hereby authorized to enter into contracts with Merging KC, Inc. for construction and associated services of Verge--A Pallet Community, that will consist of temporary shelters for a total of approximately 200 beds and related offices for security, medical and other services using a combination of funds appropriated herein in the amount of \$1,000,000.00 and funds previously appropriated in Account No. 22-2580-575201-B-G57ESGCVD19R2 in the amount of \$200,000.00.

Section 2. That the sum of \$1,700,000.00 is hereby appropriated from the Unappropriated Fund Balance of the General Fund to the following account:

22-1000-552037-B Shelter for the Homeless

\$1,700,000.00

Section 3. That the Director of Housing and Community Services is designated as requisitioning authority for Account No. 22-1000-552037.

Section 4. That this substantial amendment to the 2020 One Year Action Plan is hereby approved.

Section 5. That this ordinance, appropriating money, is recognized as an ordinance with an accelerated effective date as provided by Section 503(a)(3)(C) of the City Charter and shall take effect in accordance with Section 503 of the City Charter.

Section 6. That the solicitation requirements of Chapter 3 are hereby waived for this project.
