Plaza Westport NA has been advised that no modifications are being offered by City Planning staff to Ordinance No. 260219, modifying parking regulations. That is disappointing based on what we understood from some statements by members of the NPD Committee during the two earlier hearings. That is also inconsistent with the testimony provided by the eight concerned Midtown Neighborhood associations over those two Committee hearings.

PWNA previously asked that you direct planning staff and/or their consultant to further engage with the concerned neighborhoods to find a middle ground. That has not happened. In the absence of that effort to modify or amend Ordinance No. 260219, we would ask that you now vote no on Ordinance No. 260219 if modifications aren't made.
