## REGULATION NUMBERS 62228 THROUGH 62239 INSTALLATIONS

## TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

**Stopping, Standing and/or Parking** shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

62229	21st Street, south side, from Broadway Boulevard east 27 feet	No Parking Anytime
62230	21st Street, south side, from a point 77 feet east of Broadway Boulevard then east 12 feet	No Parking Anytime

62231	21st Street, south side, from a point 110 feet east of Broadway Boulevard then east 51 feet to Northwestern	No Parking Anytime

62232	East 74th Street, south side, from Troost Avenue to Forest Avenue	No Parking Anytime
62233	East 74th Street, north side, from Troost Avenue to Forest Avenue	No Parking Anytime
62234	Locust Street, east side, from a point 100 feet north of 135th Street then north 560 feet	No Parking Anytime
62235	Locust Street, west side, from a point 125 feet north of 135th Street then north 535 feet	No Parking Anytime

<u>Parking</u> for longer than the <u>Time Limit</u>, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in <u>Section 70-531</u>:

62236	21st Street, south side, from a point 27 feet east of Broadway Boulevard then east 50 feet	Fifteen Minute Parking
62237	21st Street, south side, from a point 89 feet east of Broadway Boulevard then east 21 feet	Fifteen Minute Parking

Reserved Parking for <u>Physically Disabled Persons</u> is hereby established, as indicated below, and shall be added to the lists as contained in <u>Sections 70-534 and 70-535</u>:

62238	Madison Avenue, east side, from a point 223 feet north of Avenida Cesar E. Chavez then south 23 feet	Accessible Parking

The locations affected by the above regulations will be marked in accordance with standards prescribed in the "Manual on Uniform Traffic Control Devices for Streets and Highways" and said regulations shall become effective five days after publication in The Daily Record.
