

COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 150705

Authorizing a Supplemental Agreement with the Missouri Department of Transportation for transferring grant funding from the Cliff Drive Recreational Improvements Project to the Cliff Drive and Spirit of KC Scenic Byways Trail Project in the amount of \$94,102.20; reducing an appropriation and revenue estimate in the Capital Improvements Fund in the amount of \$94,102.20; appropriating that amount and increasing the revenue estimate to the Cliff Drive/Spirit of KC Scenic Byway account.

WHEREAS, on November 23, 2011 and June 25, 2013, the Missouri Highways and Transportation Commission ("Commission") and the City previously entered into two Scenic Byway Grant Funds Program Agreements for public improvements designated as SBMO11001 (Ordinance No. 110815) and SBMO12001 (Ordinance No. 130440), for the construction and improvements of Cliff Drive Scenic Byways, (hereinafter, "Original Agreements"); and

WHEREAS, the Commission and the City now desire to revise the Original Agreements as provided in the Supplemental Agreement; and

WHEREAS, the Commission and the City now desire to transfer the remaining Scenic Byway Grant funds from SBMO11001 in the amount of \$94,102.20 to Scenic Byway Grant project SBMO12001; and

WHEREAS, the Parks and Recreation Department will continue to be the project administrator for the Cliff Drive Recreational Improvements and Cliff Drive and Spirit of KC Scenic Byways Trail Projects, which is the same area for which these grants apply; and

WHEREAS, the improvements include Kessler Park improvements and a multi-use trail connection between the Cliff Drive and Spirit of KC Scenic Byways that will expand the recreational opportunities of the Cliff Drive and Spirit of KC travelers; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY

Section 1. That the Director of Parks and Recreation is hereby authorized to execute a Supplemental Agreement with the Missouri Department of Transportation for transferring grant funding from the Cliff Drive Recreational Improvements Project to the Cliff Drive and Spirit of KC Scenic Byways Trail Project in the amount of \$94,102.20 in federal funds.

Section 2. That the following appropriation in the Capital Improvements Fund is hereby reduced:


