### REGULATION NUMBERS 66371 THROUGH 66381 REMOVALS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the “Code of General Ordinances of Kansas City, Missouri” and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

Prohibition of **Stopping, Standing and/or Parking**, as indicated below and as listed in **Section 70-530** is hereby discontinued at the following location(s):

33671	Baltimore Avenue, west side, from 13 <sup>th</sup> Street south 30 feet	No Parking Anytime
33672	Baltimore Avenue, west side, from 13 <sup>th</sup> Street south 31 feet	No Parking Anytime
33673	Baltimore Avenue, west side, from 14 <sup>th</sup> Street north 30 feet	No Parking Anytime
33674	Baltimore Avenue, west side, from 14 <sup>th</sup> Street north 32 feet	No Parking Anytime
33675	Genessee Street, east side, from 39 <sup>th</sup> Street south 35 feet	No Parking Day/ Night

Prohibition of **Parking** for longer than the **Time Limit**, as indicated below and as listed in **Section 70-531** and **70-591** is hereby discontinued at the following location(s):

33676	63rd Street, north side, from a point 30 feet west of Morningside Drive, then west 175 feet	Two Hour Parking from 7:00 AM to 6:00 PM Monday through Friday
33677	Genessee Street, east side, from a point 400 feet north of 40 <sup>th</sup> Street to 39th Street	Two Hour Parking from 7:00 AM to 6:00 PM Monday through Friday
33678	Genessee Street, east side, from 40 <sup>th</sup> Street north 380 feet	Two Hour Parking from 7:00 AM to 6:00 PM Monday through Friday

Reserved Parking for **Physically Disabled Persons**, as indicated below and as listed in **Sections 70-534** and **70-535** is hereby discontinued at the following location(s):

<b><u>Regulation Number</u></b>	<b><u>Location</u></b>	<b><u>Restriction</u></b>
33679	Genessee Street, east side, from a point 135 feet south of 39 <sup>th</sup> Street then south 20 feet	Four Hour Accessible Parking

The **Loading Zone**, as indicated below and as listed in **Section 70-561**, is hereby discontinued at the following location(s):

<b><u>Regulation Number</u></b>	<b><u>Location</u></b>	<b><u>Restriction</u></b>
33680	48 <sup>th</sup> Street, south side, from a point 55 feet west of Main Street then west 45 feet	No Parking Loading Zone
33681	Baltimore Avenue, east side, from a point 39 feet north of 14 <sup>th</sup> Street then north 92 feet	No Parking Loading Zone

The existing signs at the locations affected by the above regulations will be removed.
