

ORDINANCE NO. 180381

Authorizing the City Manager to enter into an employment agreement with Gary Reese; reducing an appropriation in the amount of \$234,766.00 in the Contingent Appropriation account; appropriating that amount from the Unappropriated Fund Balance of the General Fund to Fire Administration account; authorizing payment into the City of Kansas City, Missouri Firefighters' Pension System Trust to purchase creditable service on behalf of Gary Reese; and recognizing an accelerated effective date.

WHEREAS, Gary Reese has agreed to become Fire Chief; and

WHEREAS, Fire Chief is an unclassified, at will position; and

WHEREAS, Gary Reese has 23 years of creditable service in the City of Kansas City, Missouri Firefighters' Pension System Trust, and 25 years of creditable service are required for a Tier I voluntary retirement; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is authorized to execute the Employment Agreement attached to this ordinance as Exhibit A.

Section 2. That the appropriation in the following account of the General Fund is reduced by the following amount:

Section 3. That the sum of \$234,766.00 is hereby appropriated from the Unappropriated Fund Balance of the General Fund to the following account:



Section 4. That the City will contribute an amount not to exceed \$234,766.00 to the City of Kansas City, Missouri Firefighters' Pension System Trust to purchase creditable service in the System on behalf of Gary Reese. The amount of service purchased will be sufficient for Gary Reese to attain 25 years of creditable service in the System, should Gary Reese leave his position as Fire Chief prior to March 14, 2020.

Section 5. That this ordinance, appropriating of money, is hereby recognized as an ordinance with an accelerated effective date as provided by Section 503(a)(3)(C) of the City Charter and shall take effect in accordance with Section 503 of the City Charter.


