SUBJECT: Design Professional Contract recommendation for WSD Lab Modifications and Renovations Project No. 8000229, Contract No. 9522

On Tuesday, July 23, 2019, WSD advertised a request for proposals from design professionals to assist in the updating of the WSD Lab Modifications and Renovations. Work will result in a Preliminary Design Report, Schematic Design (30%), Construction Phasing Recommendation and Probable Estimate of Construction Cost and Total Project Cost.

A pre-proposal meeting was held on Thursday, July 25, 2019. Proposals were received on Tuesday, August 13, 2019.

Project Description:

The Design Consultant team will develop the project to 30% completion at which time WSD can assess the direction to proceed that best meets the needs of the Department.

The Scope of Services include a Space Planning Study; Assessment of Existing Building Systems; Lighting Study to assess the benefits of converting to LED; ADA Compliance; Building Improvements; IT Improvements; Preliminary Cost Estimates and Schematic Design to include three (3) alternatives.

Task series listing to be included in the Basic Scope of Services is organized as follows:

- 1. Task Series 100 Project Management and Administration
- 2. Task Series 200 Site Investigation
- 3. Task Series 300 Preliminary Design/ Programming Report (15%)
- 4. Task Series 400 LEED Design
- 5. Task Series 500 Schematic Design(30%)

The WSD Selection Recommendation Committee reviewed the proposals and recommended the firm of Finkle + WIlliams Architecture with the firm of The Clark Enersen Partners as the alternative selection. The Selection process also involved several members of the Selection Recommendation Committee visiting several recent, local projects by these two (2) firms.

The Selection Recommendation Committee presented their recommendation to the Selection Committee for their consideration on Dec. 24, 2019. The Selection Committee made their decision the same day.
