Accepting and approving a one year contract with the Missouri Department of Health and Senior Services to conduct Perinatal Hepatitis B case management and surveillance activities in Kansas City, Missouri; estimating and appropriating the sum of \$83,850.00, not previously appropriated, in the Health Grants Fund; and recognizing this ordinance as having an accelerated effective date.

Lisa Mertz, Health Department, presented. This ordinance approves a one year \$83,850.00 contract with the Missouri Department of Health and Senior Services for the purpose of conducting Perinatal Hepatitis B case management and surveillance activities in Kansas City, Missouri. These funds provide for identification of pregnant women who are infected with hepatitis B to provide immunization to the newborn, for household and sexual contacts to prevent hepatitis B infection. The Program routinely maintains 10-20 pregnancies through surveillance efforts and follows an additional 35-50 newborns to ensure appropriate vaccine compliance.
