Accomplishments Over the last Year

Comprehensive Review of Billing Operation

- Process Mapping to identify opportunities for improvement
- Members of KCFD, Finance and DataKC participated
- Several recommendations identified
 - Explore new billing software
 - Initiate online payment system
 - Establish communication and review between Billing and QA/QI groups
 - Work with ePCR vendor to improve patient care reports for responders
 - Re-organize staff and duties
 - Establish workforce advancement model (WAM)
 - Join American Ambulance Association to ensure best practices



Accomplishments Over the last Year

- > Stopped approving unnegotiated settlements with law firms
- > Established mechanism to receive payment online
- > Curtailed procedures for write-offs and adjustments
- ➤ Billing staff-maintained operations through out the pandemic with no substantial loss in revenue
- ➤ Received notice from Medicaid that KCFD is no longer on "Prepayment Review" for coding
- ➤ Ground Emergency Medical Transport (GEMT) Net Reimbursement \$17,608,755.23

- ➤ Initiate RFP for billing software provider
- ➤ Re-organize staff using medical billing best practices
- ➤ Establish a Workforce Advancement Model (WAM)
- Ensure secure transmittal of Documents for HIPAA compliance
- ➤ Review Medicaid "Prepayment Review" reporting
- ➤ Comply with Medicare Targeted Probe and Educate (TPE) audit
- ➤ GEMT Submitted Net Reimbursement \$8.2M
