### MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE DISTRICT

#### **NOVEMBER 29, 2018**

#### A. Time and Place

The initial meeting of the Board of Directors (the "Directors" or "Board") of the 1707 Locust Community Improvement District (the "District") was held on November 29, 2018, commencing at 2:30 p.m. at Polsinelli PC, 900 West 48<sup>th</sup> Place, Kansas City, Missouri 64112 and/or by telephone conference, after giving due notice.

#### B. Attendees; Call to Order

The following Directors were present: Josh North, Lauren Fowler, Lindsey Wade and Jesse Hufft. Also present were Matt Moriarity of Polsinelli, PC and Davis Engle of Meriwether Companies. Director Rita Burke was not present. After recognizing that a quorum of the Board was present, Matt Moriarity called the meeting to order.

#### C. Resolution 2018-1

The Board considered Resolution 2018-1, an acknowledgment of the Directors' oath of office. Following discussion, Director Jesse Hufft moved to adopt Resolution 2018-1. Director Josh North seconded the motion, and the Directors adopted Resolution 2018-1 by a unanimous vote.

#### D. Resolution 2018-2
