Dear Council and Mayor Lucas:

As a proponent of downtown Kansas City, we at Platform Ventures strongly urge the City Council to support Ordinance No. 200225, to continue the progress made on the Barney Allis Redevelopment project.

Along with many prominent businesses anchored downtown, Platform Ventures is an active investor in Kansas City and has been for approximately 15 years. Now, more than ever, we encourage the City to continue to invest in their own success and prioritize the Barney Allis Redevelopment project - even during these challenging times.

Platform Ventures is actively engaged in delivering a 3-Phase development on a full city block which is immediately adjacent to and directly to the East of the Barney Allis Redevelopment project. Total project costs are expected to be \$180mm and will result in the delivery of 151 market-rate apartments, 144 boutique hotel rooms, and a 152m SF Class-A office building accompanied by a 411-stall structured parking garage (parking will be available to the general public on nights and weekends). Mayor Lucas, Council Members and City Staff:

As the Kauffman Center for the Performing Arts nears its tenth anniversary season, we are writing to you as continued supporters of the economic development associated with downtown Kansas City's vibrant arts and cultural events scene.

While there is little doubt that the sixty-five-year-old Barney Allis Plaza and its Auditorium Plaza Garage is near end of life, our concern is the apparent lack of a plan to mitigate the parking, traffic, and economic impact of removing the currently used 740 spaces from the public parking inventory with no suitable plan to replace them during construction. We have been informed by City staff and consultants the demolition and construction project could last up to two years.

Moreover, we appear to be removing public parking inventory at a time when event demand is likely to increase. Consider the new Loew's Convention Hotel, which is scheduled for opening on April 1, 2020. Its 460 spaces will almost certainly not meet the added demand for guests and staff when they hold events in their own spaces. However, without a plan to replace the Auditorium Plaza Garage spaces, the remaining parking inventory will simply not meet a fraction of the demand in the area. The challenges become exponentially larger when ballroom events at the hotel and conference center with attendance of 1600 and 1200 occur simultaneously with any of the more than 300 performances held at the Kauffman Center annually.

Prior to funding or approving any demolition or construction project associated with Barney Allis Plaza, we respectfully request of the City's leaders and City staff to:

- 1. Complete a thorough parking and traffic impact study prior to closure of 720 spaces at Auditorium Plaza Garage. Identifying the project's impact on cultural events in the community for up to two years.
- 2. Prepare a thorough and well-conceived mitigation plan (appropriately reviewed and approved by local stakeholders) which limits the disruption to normal business operations for events in a five-block radius of Barney Allis Plaza throughout the two-year process. Specifically, the plan should identify a traffic control plan and replacement parking spaces for those which will be taken offline for the project.

The Kauffman Center and its three resident art organizations — the Kansas City Symphony, the Kansas City Ballet, and the Lyric Opera of Kansas City — have helped propel the quality of performing arts in our community to levels we never previously would have imagined...and others around the country and around the world have taken notice! We want to ensure the momentum and the welcoming environment we have created for visitors to the downtown corridor grows even stronger in the next ten years. We trust that our elected and appointed municipal leaders wish to avoid taking steps which would quickly eliminate all that we have achieved together.

In regard to this ordinance, the Downtown Council, a non-profit organization representing over 200 businesses, organizations and property owners, working to create and maintain a vibrant and sustainable urban community, supports moving forward expeditiously with the process to build a new garage and public space at Barney Allis Plaza. The existing garage cannot be fully utilized - currently, at least 250 of the 900 spaces are closed due to safety concerns and the City is constantly monitoring the garage for potential safety issues/concerns and high costs to maintain due to the age and deterioration of the facility. Recall the concern last year when a chunk of ceiling fell through the roof of a car — luckily no one was inside.

The Downtown Council, via our Open Space Committee, which includes representatives from the Downtown Neighborhood Association, hotels, and businesses adjacent to Barney Allis Plaza, has been actively studying ways to improve the garage and plaza since 2017 when we first partnered with the City to bring the Urban Land Institute - KC District Council in to study the plaza and garage. Barney Allis Plaza and the Auditorium Plaza Garage are strategically important and provide critical parking supply for conventioneers, tourists, visitors, employees and residents accessing Bartle Hall, Municipal Auditorium, KC Marriott Downtown, Aladdin and Crowne Plaza Hotels as well as other surrounding businesses. The plaza and garage should be a showcase - instead, the facility is deteriorating and even dangerous.

We understand that the City Council will be making difficult budget decisions in the upcoming months. We urge the City Council to prioritize the Barney Allis redevelopment and authorize the funds to continue the progress made thus far.
