<p>Specific Address The redevelopment area is generally bound by 63rd Street Trafficway on the north, Interstate 435 and Manchester Avenue on the east, 64th and 67th Street on the south, and the Kansas City Southern Railroad tracks on the west in Kansas City, Jackson County, Missouri (the "Redevelopment Area").</p> <p>Reason For Legislation The Ninth Amendment modifies the Winchester Housing Improvement Program as recommended by the Commission's Neighborhood & Housing Committee. The Ninth Amendment extends the Winchester Housing Program until April 2024.</p> <p>Discussion The TIF Commission's Neighborhood & Housing Committee asked for the Winchester Center TIF Housing Program to be extended as there are still funds available for use. There is a total of \$616,148 available.
