Project Location: 407 Grand Boulevard, Kansas City, Jackson County, Missouri in the Market PIEA Plan Area

Project: This project will revive a long derelict, historic building in the River Market to retain TheGymKC, a woman owned business. The 407Grand building requires extensive repairs to stabilize the structure and restore the original façade facing the street car on Grand Boulevard. The project is seeking Federal and State historic tax credits and in doing so will be restoring the original Grand Boulevard façade including operable pedestrian doors, transom windows and storefront windows.

<u>Financing</u>: The total Project cost is approximately Two Million Five Hundred Thousand Dollars (\$2,500,000).

Tax Abatement:

For 10 years the Developer will pay the land tax but the improvements will be abated 100% with a PILOT of \$1,868 for each of the 10 years.

EXPRESSING THE INTENT OF THE PLANNED INDUSTRIAL EXPANSION AUTHORITY OF KANSAS CITY, MISSOURI TO ACCEPT THE INDUSTRIAL DEVELOPMENT CONTRACT PROPOSAL SUBMITTED BY 407 GRAND, LLC FOR REDEVELOPMENT OF THE 407 GRAND PROJECT

WHEREAS, the City Council of Kansas City, Missouri (the "City Council") has heretofore passed Ordinance No. 56866, the General Development Plan (the "Plan") for the Market PIEA Planning Area (the "Plan Area") as prepared by the Planned Industrial Expansion Authority of Kansas City, Missouri (the "Authority"); and approving the General Development Plan for the Plan Area; and

WHEREAS, after public notice as required in §100.410 RSMo, the Authority duly considered all proposals and the financial and legal ability of prospective developers to carry out proposals to develop projects in the Plan Area.

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNED INDUSTRIAL EXPANSION AUTHORITY OF KANSAS CITY, MISSOURI as follows:

- Section 1. That the Planned Industrial Expansion Authority of Kansas City, Missouri does hereby declare its intent as required in §100.400 RSMo to accept the Industrial Development Contract Proposal of 407 Grand, LLC for the 407 Grand Project as described in Exhibit A attached hereto and, in accordance with Section 100.400 I(10), RSMo., declare that inconsistencies, if any, between said proposal and the General Development Plan are minor.
- Section 2. The Authority finds that development in accordance with the proposal submitted by 407 Grand, LLC will be in the public interest and in furtherance of the purposes of the Planned Industrial Expansion Law, §100.300-100.620 RSMo.
- Section 3. With the adoption of this Resolution, the Authority does hereby notify the City Council of Kansas City, Missouri of the Authority's intent to accept said industrial development contract proposal and herein directs the Executive Director of the Authority to provide said City Council with such written notice as required by law.
