Dear Mayor Lucas and Members of the KCMO City Council:

This letter is to inform the Mayor and the City Council that the University of Missouri-Kansas City Board of Trustees is opposed to the proposed rezoning of 5220 Troost Avenue from its current designation of R 1.5.

The Board of Trustees is comprised of civic, philanthropic, and community leaders. Our mission is to strengthen Kansas City's future by advocating for and supporting UMKC and its students. The Board of Trustees must keep the best long-term interest of the university in mind, and this proposal is counter to the vision for both the campus and the surrounding area.

Specifically, we, along with UMKC Chancellor Agrawal, are opposed to this recent proposal that the property be developed as a drug rehabilitation facility. These proposed changes would permit a variety of uses not suitable for the unique location of the property, which borders two universities and is adjacent to a nearby childcare facility.


