PURPOSES OF CID AND SERVICES PERFORMED DURING FISCAL YEAR 2022

Purpose:

- a) provide or cause to be provided for the benefit of the District, certain services described in Paragraph 3B of the Petition (the "Eligible Services");
- b) borrow money ("CID Debt") from any public or private source to finance the costs of the Eligible Services and other costs incurred by the District to carry out its purposes and for the repayment of the same, provided that the District's borrowing capacity shall be limited to \$1,581,008 ("CID Debt Cap"); and
- c) authorize and collect sales and use tax ("District Sales Tax").

Services:

The Eligible Services may generally include, but are not necessarily limited to, earthwork, installation of geo-piers, paving and construction of parking lots, water distribution, a fire line, storm drainage, sanitary sewer and sanitary sewer relocation, landscaping, green space and irrigation, construction of curbs, gutters, approaches, sidewalks and electrical distribution, streetlights, and site lighting, and overall rehabilitation of the District. The estimated initial costs of the Eligible Services are shown on Exhibit C of the Petition ("Estimated Cost of Eligible Services") annexed to and made an integral part of this Petition.

No 2022 annual budget was approved, as the CID was not established until February 10, 2022.

RESOLUTION OF THE TIFFANY SQUARE EAST COMMUNITY IMPROVEMENT DISTRICT (THE "DISTRICT"), APPROVING A ONE PERCENT (1.0%) SALES AND USE TAX (THE "DISTRICT SALES TAX") TO BE PRESENTED TO QUALIFIED VOTERS IN THE DISTRICT FOR THEIR APPROVAL IN A MAIL-IN ELECTION, PURSUANT TO STATUTE

WHEREAS, the District, which was formed by Ordinance No. 220088 adopted by the City Council of Kansas City, Missouri, is a public body created under the authority of the "Missouri Community Improvement District Act," Section 67.1401, *et seq.*, RSMo, as may be amended (the "Act"); and is transacting business and exercising powers granted by the Act;

WHEREAS, the District desires to: (1) provide or cause to be provided, within and for the benefit of the District, (a) construction of vehicular and pedestrian accessibility improvements, (b) remediation of subsurface conditions which are presently unsuitable for fill and development, and shall specifically include earthwork, installation of geo-piers, paving and construction of parking lots, water distribution, a fire line, storm drainage, sanitary sewer and sanitary sewer relocation, landscaping, green space and irrigation, and (c) construction of curbs, gutters, approaches, sidewalks and electrical distribution, street lights, and site lighting (collectively, the "Eligible Services"); (2) issue obligations ("CID Debt") to finance (a) the costs of the Eligible Services, (b) other costs incurred by the District to carry out its purposes, (c) costs of issuance, (d) capitalized interest and (e) a debt service reserve fund related to the issuance of the CID Debt; (3) authorize and collect a sales and use tax; and (4) provide for any other actions required in the furtherance of the above stated objectives (collectively, the "District Purposes"), as the Board deems necessary, and as authorized pursuant to the Act, including those items described in Section 67.1461.1 and Section 67.1461.2(1) and (2) RSMo, as amended;

WHEREAS, Section 67.1545, RSMo authorizes the Board of the District to submit a District Sales Tax proposal to an election by the qualified voters of the District for the purposes of funding the District Purposes;

WHEREAS, Section 67.1545, RSMo authorizes the use of a mail-in election procedure for such District Sales Tax proposal;

WHEREAS, the Board of the District desires to submit to the qualified voters of the District to approve a one percent (1.0%) District Sales Tax on sales in the District for a period ending upon the earlier of twenty-seven (27) years from the date on which the District Sales Tax is first imposed, or until such time as the District is terminated (if such time is less than twenty-seven (27) years);

WHEREAS, the District Sales Tax will be imposed on all retail sales made in the District which are subject to taxation pursuant to the provisions of Sections 144.010 to 144.525, RSMo, except sales of motor vehicles, trailers, boats or outboard motors and sales to public utilities; and

WHEREAS, the funds to be raised by the District Sales Tax are necessary to fund the District Purposes.

NOW, THEREFORE, BE IT RESOLVED by the Board of the District as follows:

1. That the Board approves the submission of a one percent (1.0%) District Sales Tax on all retail sales made in the District which are subject to taxation under Sections 144.010 to 144.525, RSMo, to the qualified voters of the District for their approval in accordance with the mail-in provisions of Section 67.1545, RSMo, and as ordered by the City Council of the City of Kansas City, Missouri, pursuant to the following ballot proposition:

Shall the Tiffany Square East Community Improvement District impose a community improvement district-wide sales and use tax (the "District Sales Tax") at the maximum rate of one percent (1.0%) for a period ending upon the earlier of twenty-seven (27) years from the date on which the District Sales Tax is first imposed, or until such time as the District is terminated (if such time is less than twenty-seven (27) years), for the purpose of providing revenue for the following district purposes (collectively the "District Purposes"): (1) provide or cause to be provided, within and for the benefit of the District, (a) construction of vehicular and pedestrian accessibility improvements, (b) remediation of subsurface conditions which are presently unsuitable for fill and development, and shall specifically include earthwork, installation of geo-piers, paving and construction of parking lots, water distribution, a fire line, storm drainage, sanitary sewer and sanitary sewer relocation, landscaping, green space and irrigation, and (c) construction of curbs, gutters, approaches, sidewalks and electrical distribution, street lights, and site lighting (collectively, the "Eligible Services"); (2) issue obligations ("CID Debt") to finance (a) the costs of the Eligible Services, (b) other costs incurred by the District to carry out its purposes, (c) costs of issuance, (d) capitalized interest and (e) a debt service reserve fund related to the issuance of the CID Debt; (3) authorize and collect a sales and use tax; and (4) provide for any other actions required in the furtherance of the above stated objectives, as the Board deems necessary, and as authorized pursuant to the Act, including those items described in Section 67.1461.1 and Section 67.1461.2(1) and (2) RSMo, as amended.

Upon approval of the District Sales Tax by the qualified voters of the District, pursuant to Section 67.1545.3 RSMo, the District Sales Tax shall become effective on the first day of the second calendar quarter after the director of the Department of Revenue receives notice of the adoption of the District Sales Tax.
4. The District Manager is authorized and directed to take all further action necessary to carry out the purpose and intent of this Resolution.
5. This resolution shall take effect immediately.





WHEREAS, the District, which was formed by Ordinance No. 220088 adopted by the City Council of Kansas City, Missouri, is a public body created under the authority of the "Missouri Community Improvement District Act," Section 67.1401, *et seq.*, RSMo, as may be amended (the "Act"); and is transacting business and exercising powers granted by the Act;

WHEREAS, the Board of Directors (the "Board") of the District desires to establish a bank account or bank accounts with a Missouri Bank (the "Bank") for the deposit of sales tax revenues, special assessment revenues, if any, and other monies paid to the District (the "Account(s)");

WHEREAS, the Board of the District desires to have the Missouri Department of Revenue (the "MO DOR") deposit sales tax revenues into the Bank via Automated Clearing House (the "ACH") transfers in accordance with the form attached hereto as Exhibit A;

WHEREAS, the Board of the District desires to have a monthly accounting by the MO DOR forwarded to its counsel setting forth the names of the businesses and the amount of sales and/or use taxes collected from the businesses located within the District, in accordance with Form 4379 attached hereto as Exhibit B;

WHEREAS, the Board of the District desires to apply to MO DOR for exemption from Missouri Sales/Use Taxes in accordance with Form 1746 attached hereto as Exhibit C; and

WHEREAS, the Board of the District desires to apply for a federal employee tax identification number ("FEIN") for reporting and accounting purposes in accordance with Form SS-4 attached hereto as Exhibit D.

NOW, THEREFORE, BE IT RESOLVED by the Board of the District as follows:

1. The District Manager is authorized to select a Bank and establish an Account or Accounts for the deposit of sales tax revenues, special assessment revenues, if any, and other monies paid to the District.

2. The Chairman and Treasurer are authorized to deposit all monies paid to the District in the name of the District in the Account(s) at the selected depository, to write and sign Account(s) checks and to perform tasks incidental to the maintenance of the Account(s).
3. All Account(s) checks shall be signed by both the Chairman and the Treasurer.
4. The Chairman and Treasurer are authorized to execute the MO DOR ACH Agreement, in substantially the format attached hereto as Exhibit A, in order for the District's sales tax revenues to be deposited into the Account via ACH transfer.
5. The Chairman is authorized to execute MO DOR Form 4379, in substantially the format attached hereto as Exhibit B, directing the MO DOR to send monthly accounting reports to the District's counsel setting forth the names of the businesses and the amount of sales tax revenues collected from those businesses located within the boundaries of the District.
6. The Chairman and Secretary are authorized to execute MO DOR Form 1746, in substantially the format attached hereto as Exhibit C, requesting that MO DOR issue a certificate exempting the District from payment of Missouri sales/use taxes.
7. The Chairman or District Manager is authorized to execute Internal Revenue Service Form SS-4, in substantially the format attached hereto as Exhibit D, requesting a FEIN from the Internal Revenue Service for reporting and accounting purposes of the District.
8. The Chairman and Treasurer are authorized and directed to take all further action necessary to carry out the purposes and intent of this Resolution.
9. This resolution shall take effect immediately.
