Authorizing a Lease Agreement with FAA, Contract #6223030046 at Kansas City International Airport.

Discussion

Authorizing Lease Agreement #6223030046 for Antenna and Equipment Space on the southwest exterior corner of the KCI Maintenance and Repair Base Building (formerly known as the Over Haul Base) from October 1, 2022 to September 30, 2032.

The original Lease term began March 1, 2017 and ended September 30, 2021, it is currently in a Holdover period. The ASSC RU #5 Site (Airport Surface Surveillance Capability Remote Unit #5) is one of eleven (11) other such sites located around KCI and are related to the FAA's activities in support of the National Airspace System (NAS).

Beginning October 1, 2022 FAA will pay the annual rental rate of \$587.00 for Years 1 - 5, and then \$675.00 for Years 6 - 10.
