Executive Summary

Authorizing a \$1,878,800.00 construction contract with Infrastructure Solutions, LLC, for the Water Main Replacement along 1st Street/Guinotte Avenue, Campbell Street to I-35/I-29 project; and authorizing a maximum expenditure of \$2,066,680.00.

Discussion

Project Justification

The Water Services Department is undertaking this construction project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection to replace aging, break-prone cast iron (CIP) water mains with ductile iron pipe (DIP).

Project Description

This Project in general consists of replacing approximately 3,000 LF of 8-inch break-prone or obsolete water mains and appurtenances and providing other distribution system improvements within the project limits, generally defined as E. 1st Street, Guinotte Avenue, Campbell Street to I-35/I-29 Highways, in Kansas City, Jackson County, Missouri.

The specific mains to be replaced and other distribution system improvements within the project limits consist of the following: Replacement of approximately 3,000 LF of 8-inch CIP water main with 8-inch DIP along E. 1st Street (Guinotte Avenue) starting from a point of 400 feet west of Campbell Street and continuing east to I/35/I-29 overpass.

The work will include the transfer of customers' water service connections from existing water mains to new water mains, as well as restoration of roads and properties. The amount of this contract is \$1,878,800.00.

The term of this contract is 240 calendar days.

Solicitation

This project was advertised in accordance with the City's requirements. Public bids were opened on May 2, 2023 with 5 bidders responding.

Infrastructure Solutions, LLC was selected for this project as the lowest, most responsive, and most responsible bidder with a contract amount of \$1,878,800.00, with subcontracting participation of 11% MBE and 11% WBE.
