Executive Summary

Authorizing the Chief Procurement Officer to enter into a one-year contract (EVP3902) with ConvergeOne Inc. for Dell products and services and to renew the contract for available renewal years.

FY24 spend will be ARPA grant funds. However, future purchases will be funded by each department, as needed. The departments must have funds in their approved departmental budget to cover the cost of services. This ordinance does not encumber or appropriate funds.

Discussion

The City's primary and backup data centers hardware has reached the end of its useful life expectancy. This request will allow the General Services Departments, Information Technology Division to replace the core computing infrastructure in order to provide citywide computer operations with a high level of service required to run the critical centralized applications such as PeopleSoft (Finance & HR), EnerGov (Permitting System), GIS (Geographic Information Systems), and iNOVAH (cashiering).

The work will include:

- 1. Replacing our current 5-year-old hardware with up-to-date hardware
- 2. Improved security and reliability
- 3. Capacity for data center consolidation and growth as identified in the citywide IT consolidation plan

This contract was competively awarded through Cooperating School Districts of Greater Kansas City. They issued a competitive Request for Proposal and awarded their contract to ConvergeOne Inc.

The City of Kansas City, MO is able to utilize this award and purchase from contract and take advantage of volume pricing and discounts.
