# **Executive Summary**

Authorizing a \$400,000.00 design professional services contract with Jacobs Engineering Group, Inc. for the Smart Sewer Flow Data Analytics project; and authorizing two successive one-year renewal options for a maximum expenditure of \$1,200,000.00 with further City Council approval.

#### **Discussion**

#### **Project Justification**

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system over a 25-year period. In March 2021, the Consent Decree was modified to include additional interim and revised final performance criteria and to extend its duration to 30 years. The City's Smart Sewer Program is currently in year 13 of a 30year implementation period.

The Smart Sewer program uses strategic, data-driven solutions and innovative overflow control technologies to ensure the improvements and investments we make today will last for generations to come. Smart solutions capitalize on enhanced sewer system asset condition and performance data, and innovative technologies to minimize cost and maximize the benefits. Combined with continued efforts on the system-wide hydraulic model and asset data management systems, the sensor network and data analytics will support KC Water's continued journey of digital transformation to optimize needed capital investments for the Smart Sewer Program implementation, as well as necessary system operational, maintenance and asset management expenditures.

The City is continuing to operate, maintain, and expand the existing Smart Sensor Network within the sewer system and continues data collection services. The purpose of this project is to utilize data collected from the Smart Sensor Network to perform data analytics in support of various sewer management functions, to support the development of strategies for evolving data driven system engineering, operations, and maintenance, and to support data dashboards and decision support systems.

#### **Project Description:**

The scope of work to be performed under this contract entails the following services:

 Developing near- and long-term strategies to advance the data-driven sewer system operations.

- Developing/maintaining/enhancing the roadmap for data dashboards for an Intelligent Wastewater Platform.
- Advancing data analytics to serve multiple use cases with deep learning and intelligence interfaced with KC Water's new wastewater SCADA system.

This contract will have a 12-month service period, in the amount of \$400,000.00.

# Solicitation:

The Request for Proposals/Qualifications for this project was advertised in accordance with the City's requirements on November 19, 2021. Three proposals were received on December 20, 2021.

#### Consultant Selection/Subcontracting Participation:

Jacobs Engineering Group, Inc. was selected for this project in accordance with Code of Ordinance Section 3-31(b)(1), Citywide selection with subcontracting participation of 8% MBE and 8% WBE.

Tetra Tech, Inc.

Xylem Inc.

The City's estimated cost for this project is \$400,000.00.
