Executive Summary

Authorizing the Director of Public Works to execute a construction contract with the Kansas City Streetcar Constructors ("KCSC") in an amount not to exceed \$1,600,000 for construction services to support the Linwood and Main intersection improvement project; waiving contract solicitation and award provisions; and recognizing this ordinance as having an accelerated effective date.

Discussion

KCSC has specialized and specific project experience related to the improvements to Linwood Boulevard and Main Street and public solicitation would result in increased costs and delay, and therefore, it is in the best interests of the City to waive the contract solicitation and award provisions.
