### **Cooperative Agreements**

- Vast majority of Coop. Agreements contain language already found in Chapter 74.
  - "Each CID shall enter into a cooperative agreement with the city that addresses, among other things, requirements of this article and state statute."

Requirements	Coop.	Chapter 74
Submission of Proposed	<b>~</b>	<b>~</b>
Submission of Annual Report	<b>~</b>	<b>/</b>
Payment of late submittal fine	<b>~</b>	<b>~</b>

#### **Cooperative Agreements**

- Coop. agreements allow enforcement in courts, Chapter 74 allows for administrative citations
- Agreements can't be signed until board is formed
  - Procedure moving forward: Board resolutions must be submitted with Annual Reports, follow up on Coop. Agreement at that time



#### **Cooperative Agreements**

 90 CIDs: 26 executed, 8 awaiting District signatures, 3 new with no board

Creation timeframe	Number of CIDs	Cooperative Agreement Policy
Prior to 2013	30	No requirement
2013-2022	53	Only required when improving ROW or supporting business activities/economic development
2022-Present	7	Required for all

- City staff reporting date- Nov. 1st change to Dec. 1st
  - Ordinance No. 240024
- Termination of non-compliant and/or defunct CIDs
  - Not allowed per RSMo Section 67.1481
