### ORDINANCE NO. 240089

Vacating the Gabriel Condominium Plat, generally located at 625 E. Armour Boulevard; and directing the City Clerk to record certain documents. (CD-ROW-2023-00047)

### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1.
