Brief Title

Approving the plat of Brighton Creek Crossing, an addition in Kansas City, Clay County, Missouri

Specific Address

Approximately 17.63 acres generally located at the southeast corner of N. Brighton Avenue & Highway 152, creating 4 lots and 1 tract.

Reason for Project

This final plat application was initiated by Beck-Cal LLC, in order to subdivide the property in accordance with the city codes and state statutes. (The developer intends to construct a 4 lot commercial development.)

Discussion

This is a routine final plat ordinance that authorizes staff to continue to process the plat for recording. This plat can be added to the consent agenda.

CONTROLLING CASE

Ordinance No. 080473 - On June 26, 2008 the Council approved a rezoning of approximately 19.8 acres generally located at the southeast corner of Missouri Highway 152 and N. Brighton Avenue from District C-2 to District PD/C-2 and approved a preliminary development plan for the same. (13087-PD-7)
