WHEREAS, over the past few decades, housing costs have risen faster than incomes, driving more and more families and individuals into houselessness; and

WHEREAS, over the past two years, the COVID-19 pandemic has accelerated the impact of job and income loss, driving additional families and individuals into homelessness at an everincreasing rate; and

WHEREAS, current efforts to respond to this increased demand for shelter, food, ______ medical and other services in support of the houseless population, although well-_intendedand helpful in the moment, have not provided an ongoing or long-term solution; and

WHEREAS, the City issued a request for proposals (RFP) seeking proposals from qualified respondents for the creation of new housing solutions that provide temporary, transitional, and permanent housing options for residents that are houseless and/or at the lowest income levels; and

WHEREAS, Amethyst Place submitted a proposal to provide permanent supportive housing for single mothers and children; and

<u>WHEREAS</u>, the City has selected <u>proposersAmethyst Place</u> who each have aprovided unique <u>wayways</u> of helping the <u>City take the next steps in addressing houselessness and low-</u>income housing; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY THAT:

Section 1. <u>That the The</u> Director of Housing and Community Development is herebyauthorized to enter into agreements an agreement with XXXXXXXAmethyst Place in the amount of \$300,000.00 from funds previously appropriated in Account No. 22-1000-552037-B for predevelopment money towards the creation of 34 additional units to serve single mothers and children who are houseless and/or at the lowest income levels.
