AGENDA ITEMS AND DISCUSSION

Welcome and Introductions

Samantha Collison called the meeting to order at 10:34AM.

- Welcome and Introductions
 - o Welcomes Laine as she will be taking over Samantha Collinson's previous role at University Health
- Review of October 20th, 2021 Minutes
 - Motion: Tracy Russel motioned to approve the October 20th,2021 minutes. Deidra West seconded.
 Unanimously approved.

Old Business

Legislative Update by Tracy Russel

- Latest Federal Build Back Better plan does extend Post-partem coverage in Medicaid for one year
- The Federal House of Representatives have put language back into the Build Back Better plan for paid family leave for 4-weeks
 - The Paid Family Leave was one of the last things to be taken out earlier in the year at the behest of Senator Joe Manchin
 - o The United States is 1 of 6 developed nations that do not offer paid family leave
 - The house is expected to vote on the Build Back Better Act the week of November 15th, and it will then be sent over to the Senate if it passes
- The state of Missouri is working on a bill to extend post-partem coverage in Medicaid for the State of Missouri in case the federal legislation does not pass
- On November 16th, 2021 the Federal House of Representatives passed the Protecting Moms Who Serve ACT
 - This bill requires the Department of Veteran Affairs (VA) to implement the maternity care coordination program
 - The VA must provide community maternity care providers with training and support with the unique needs of pregnant and postpartum veterans particularly regarding mental and behavioral health conditions
 - Passed through the Federal House of Representatives with a vote of 414-9 vote
 - This was one of the bills that made up the Black Momnibus Act to pass both the House of Representatives and the Senate and waiting to be signed by the President of the United States

Best Babies Zone Updates and Recommendations

- Nurse Update by Hillary Lindstrom
 - Replacing Josie Adams as the Nurse Family Partnership (NFP) Director
 - Nurse Family Partnership specifically focused on zip code 64128 and other zip codes with the highest infant mortality rates
 - o Recently transitioned into this position so has not been able to attend the Best Babies Zone meetings
 - o In general, there has not been a lot of referrals from the 64128-zip code
 - Nurse Family Partnership do not have a dedicated nurse for this zip code
 - o The Nurse Family Partnership is state funded serving seven different counties the nurses case load is full and are unable to provide a nurse dedicated to the 64128-zip code
 - The 64128-zip code does have priority in referrals to services
 - Health Levy fund could be one way to get a nurse to serve as the 64128-zip code sole administrator
 - The commission agrees that the priorities should be going to the zip codes with the greatest infant mortality rate

- Near Miss Review Board by Hakima Payne
 - o Completed the template
 - Will not have a meeting in December
 - o Next steps get input from community stakeholders and to get funding for a pilot program
- Health Equity Updates
