WHEREAS, Port KC is the recipient of a Missouri ARPA Industrial Site Development Grant for infrastructure improvements which includes North Mexico City Avenue and impact fee allocations for this project will provide gap funding for construction of the project; and

WHEREAS, North Platte Purchase Drive is in the Platte Purchase TIF boundary and plan and impact fee allocations for this project will accelerate the design and construction schedule and NOW, THEREFORE,

## **Executive Summary**

Approving the recommendations of Arterial Street Impact Fee District A Committee; Appropriating \$1,898,930.60 from the Unappropriated Fund Balance of the Arterial Street Impact Fee Fund to accounts in the Arterial Street Impact Fee Fund; authorizing the Public Works Director to enter into a Funding Agreement with Port KC in the amount of \$1,698,930.60 for North Mexico City Avenue. construction; and a Funding Agreement with the Tax Increment Financing Commission in the amount of \$200,000.00 for North Platte Purchase Drive conceptual roadway plans; and recognizing this ordinance as having an accelerated effective date.

#### **Discussion**

This ordinance allocates funds from Arterial Street Impact Fee District A (Airport Development Impact District) to two projects within said district. On February 5, 2024, the Arterial Street Impact Fee District A Committee recommended:

- (1) allocating \$1,698,930.60 for the construction of N Mexico City Ave from NW 132nd St to NW 136th St to provide gap funding in conjunction with a Missouri ARPA Industrial Site Development Grant received by Port KC, and
- (2) allocating \$200,000.00 for the conceptual design of improvements to N Platte Purchase Dr from NW 104th St to NW 95th St to accelerate the design and construction schedule of this project within the Platte Purchase TIF boundary.

Additionally, the ordinance gives requisitioning authority to the Director of Public Works for the Airport Development Impact District funds and authorizes the Director of Public Works to execute separate Funding Agreements with Port KC and the Tax Increment Financing Commission for these projects.

Expressing the City Council's support for the City's grant application for the Bridge Investment Program (BIP) Project in the amount of \$36,981,958.00, which would require local matching funds up to the amount of \$9,245,490.00, and directing the City Manager to submit the application for the Bridge Investment Program.

WHEREAS, Public Works has identified nine (9) top priority bridges that are structurally deficient and/or functionally obsolete which require rehabilitation or reconstruction to preserve mobility and accessibility. These bridges are:

- 1. 112th Street over Fishing River
- 2. Pleasant Valley Road over Big Shoal Creek
- 3. 12th Street over Big Blue River
- 4. Belleview Avenue over Brush Creek
- 5. Roanoke Parkway over Brush Creek
- 6. Benton Boulevard over Brush Creek
- 7. Elmwood Avenue over Brush Creek
- 8. Gregory Boulevard over Big Blue River
- 9. Hillcrest Road over Small Creek; and

WHEREAS, the US Department of Transportation provides funding for bridge replacement and rehabilitation projects through the BIP grant with a 80% federal and 20% local match requirement; and

WHEREAS, the anticipated cost of rehabilitating/replacing these nine bridges is estimated at \$46,227,448.00; and

WHEREAS, local matching funds are required up to the amount of \$9,245,490.00 based on the cost estimates; and

WHEREAS, the City of Kansas City has already appropriated a total of \$9,245,490.00 in GO Bond funds towards bridges on this priority list; and

WHEREAS, this project will improve reliability in our infrastructure and increase mobility by adding pedestrian and cycling modes of transportation to bridges; NOW, THEREFORE,

#### BE IT RESOLVED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Council hereby expresses support for a grant application for the Bridge Investment Program and expresses its intent to provide matching local funds, as required by the grant obligations.

Section 2. That the City Manager is directed to submit a grant application for the Bridge Investment Program. ..end

## **Executive Summary**

Resolution expressing support and matching funds for a Bridge Investment Program (BIP) grant that will rehabilitate or reconstruct nine (9) city bridges. The grant being requested is approximately \$36,981,958 with a 20% local match totaling \$9,245,490.

#### **Discussion**

Public Works has identified nine priority bridges that are in need of reconstruction or rehabilitation. These bridges are eligible for a US Department of Transportation grant through the Bridge Investment Program (BIP) that funds projects at 80% federal and requires a 20% local match. The total cost or rebuilding or rehabilitating the nine identified bridges \$46.7M. Kansas City currently has appropriated or identified \$16.2M for four of these bridges. We are looking to leverage these local funds by completing nine bridges while using only 58% of the allocated funds. The bridge projects will incorporate sidewalks and bicycle facilities.

#### **Discussion**

We are looking to leverage these local funds by completing eight projects and only using \$12.2M in city funds, saving \$13.2M in city funds. The projects will incorporate sidewalks and bicycle facilities, spur economic activity, and replace aging infrastructure.

# **Executive Summary**

### **Discussion**

#### Reason for Contract

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system. The City's Smart Sewer Program is currently in year 14 of a 30-year implementation period. The purpose of this project is to reduce inflow and infiltration (I/I) flows in the sanitary sewer system. System information was gathered to identify and quantify I/I sources and to develop rehabilitation and I/I source reduction recommendations. Activities will include various sewer rehabilitation methods to reduce I/I and to restore the service life of existing sewers in the project area.

#### Construction Contract Description

The scope of work to be provided under the construction contract includes rehabilitation or replacement of approximately 370 manholes, 29,000 linear feet (LF) of sewer main ranging in diameter from 8-inches to 24-inches, and 470 associated services lateral connections. The total amount of the proposed construction contract is \$6,045,610.00.

The term of this project will be 480 calendar days.

#### Solicitation

I/I Reduction: Northern Basin Project 1 was advertised in accordance with the City's requirements on December 18, 2023, and bids were opened on January 23, 2024, with two (2) bidders responding.



## **Executive Summary**

Authorizing a \$2,741,000 progressive design-build services contract with Burns & McDonnell Engineering Company, Inc., for Phase 1 services for the Dr. Jeremiah Cameron Park and Westport Stormwater Improvements project; and providing for successive Phase 2 services subject to City Council approval.

#### **Discussion**

#### **Project Justification/Description**

The primary objective of the Dr. Jeremiah Cameron Park and Westport Stormwater Improvements project is to implement stormwater improvements to alleviate frequent flooding in Westport. Dr. Jeremiah Cameron Park is a critical location for underground stormwater storage for this project, as it is the last opportunity to manage the discharge from proposed stormwater improvements before it enters the existing combined sewer system. The storage volume is critical to providing flood benefits to Westport without negatively impacting combined sewer overflows downstream.

The park is small, thus requiring a deep underground storage facility to meet the targeted storage volume of 2 MG (million gallons). The invert elevation of the existing downstream combined sewer system limits the maximum depth of the underground storage facility while allowing for positive drainage to dewater the chambers.

The Dr. Jeremiah Cameron Park and Westport Stormwater Improvements project will be implemented using a progressive design-build project delivery approach that enables comprehensive programming, planning, design, and construction services to be completed in the following two phases:

Phase 1 Services: Contractor will complete pre-final design of the proposed stormwater improvements defining project scope, requirements, plans, and specifications to a level of detail adequate for establishment of a Contract Price for Phase 2 services.

Phase 2 Services: Contractor's services shall consist of the completion of design services, the procurement of all materials and equipment, the performance of

construction services, the start-up, testing, and commissioning, and the provision of warranty services, all of which will be further described in the future Phase 2 Contract Price Amendment.

This proposed ordinance is for authorization of Phase 1 design-build services based on Water Services Department project criteria and the level of completion required for Contractor and the Director of the Water Services Department to establish the Contract Price for subsequent Phase 2 design-build services, subject to City Council approval. This project will be constructed in three construction packages under Phase 2 design-build services. The limits of the work in each construction package and the Contract Times will be determined based on the availability of project funding. The first construction package for this project will be for stormwater improvements work at Dr. Jeremiah Cameron Park and subsequent construction packages 2 and 3 will implement stormwater improvements along Mill Street to Southwest Trafficway.

#### Term

The term of Phase 1 for this project will be 245 days.

#### ORDINANCE NO. 240324

Sponsor: Councilmember Melissa Robinson

Amending Chapter 3 of the Code of Ordinances of the Kansas City, Missouri, Contracts and Leases, by repealing Section 3-31, Contract Award, and enacting in lieu thereof a new section of like number and subject matter.

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 3, Code of Ordinances, entitled "Contracts and Leases," relating to Contract Award, is hereby amended by repealing Section 3-31, and enacting in lieu thereof a new section of like number and subject matter, to read as follows:

#### Sec. 3-31. Contract award.

- (a) General standard. Except as otherwise provided in this division 2, all contracts in which bids or proposals were required shall be awarded to the lowest and best bidder or best proposer as determined by the city in the city's sole discretion, after due opportunity for competition.
- (b) Design professional contracts. A qualification based selection shall be made based upon the statement of qualifications that was required to be submitted and any supplement thereto as requested by the city. The process for making the qualification based selection shall be determined by the estimated dollar value of the design professional contract as follows, provided however that the failure to utilize the applicable process shall not invalidate any public improvement procurement or any contract:
  - (1) Contracts exceeding \$600,000.00. The city shall convene an architect and engineering selection committee, which committee shall rank the firms from most to least qualified. The committee shall be comprised of at least one member designated by the city manager and two members designated by the director of the contracting department. The mayor may elect to be a member of the committee or may designate a council member to serve on the committee and if the mayor so elects, the director of the contracting department shall designate one less member to the committee.
  - (2) Contracts less than \$600,000.00. The director of the contracting department shall rank the firms from most to least qualified. If the cost proposal from the highest

ranked firm is an amount that exceeds \$700,000.00, the director shall not recommend award and the director shall convene an architect and engineering selection committee in accordance with Section 3-31(b)(1).

The city shall thereafter negotiate a contract for the project with the firm selected as most qualified. If the city is unable to negotiate a satisfactory contract with the firm selected, negotiations with that firm shall be terminated. The city shall then undertake negotiations with another of the qualified firms selected. If there is no agreement with the second firm, negotiations with such firm shall be terminated. The city shall then undertake negotiations with the third qualified firm. If the city is unable to negotiate a contract with any of the selected firms, the city shall reevaluate the necessary architectural, engineering or land surveying services, including the scope and reasonable fee requirements, and again conduct a qualification based selection process. Notwithstanding the foregoing, nothing herein shall obligate the city to undertake any negotiations if the city shall have determined to terminate the solicitation for any or no reason.

- (c) *Design-build contracts*. Contracts shall be awarded as is appropriate to the manner in which the contract was solicited, as follows:
  - (1) Best value. To the responsible design-build firm whose proposal is evaluated as providing the best value to the city based on any factors and method and formula included in the request for proposals. The city may elect to establish a fixed dollar budget for the project such that all proposers are operating under the same monetary limitations.
  - (2) Qualification-based. A qualification based selection shall be made based upon the statement of qualifications that was required to be submitted. The process for making the qualification based selection shall be determined by the estimated dollar value of the design-build contract as follows, provided however that the failure to utilize the applicable process shall not invalidate any public improvement procurement or any contract:
    - i. Contracts exceeding \$6,000,000,00. The city shall convene an architect and engineering selection committee, which committee shall rank the design-builder from most to least qualified. The committee shall be comprised of one member designated by the city manager and four members designated by the director of the contracting department. The mayor may elect to be a member of the committee or may designate a council member to serve on the committee and if the mayor so elects, the director of the contracting department shall designate one less member to the committee.
    - ii. Contracts \$6,000,000.00 or less. The director of the contracting department shall rank the design-builder from most to least qualified. If the cost proposal from the highest ranked firm is an amount that exceeds \$7,000,000.00, the director shall not recommend award and the director

shall convene an architect and engineering selection committee in accordance with Section 3-31(c)(2)(i). The city shall thereafter negotiate a contract for the project with the firm selected as most qualified. If the city is unable to negotiate a satisfactory contract with the firm selected, negotiations with that firm shall be terminated. The city shall then undertake negotiations with another of the qualified firms selected. If there is no agreement with the second firm, negotiations with such firm shall be terminated. The city shall then undertake negotiations with the third qualified firm. If the city is unable to negotiate a contract with any of the selected firms, the city shall reevaluate the scope of the project and again conduct a qualification based selection process. Notwithstanding the foregoing, nothing herein shall obligate the city to undertake any negotiations if the city shall have determined to terminate the solicitation for any or no reason.

(3) Two-phase. The design-builders shall be ranked from most to least qualified in such manner as provided in subsection (c)(2) and a value shall be assigned based upon the rankings. The city shall thereafter evaluate and score any proposal or bid required to be submitted and shall identify the best proposal or the lowest and best bid, as applicable. The city shall thereafter negotiate a contract for the project with the firm selected as having the best proposal or execute a contract for the project with the firm having the lowest and best bid. If the city is unable to negotiate a satisfactory contract or execute a contract, the city shall then proceed to the next best proposal or next lowest and best bid, and such process shall continue in similar fashion unless the city shall have determined to terminate the solicitation.

Previously, the director was authorized to award contract when the highest rank proposal exceeded the \$600,000.00 estimate.

**Design-Build contracts that are estimated to not exceed \$6,000,000.00**: If the cost proposal from the highest ranked firm is an amount that exceeds \$7,000,000.00, the director cannot recommend award and the director is required to convene an architect and engineering selection committee in accordance with Section 3-31(c)(2)(i) to reevaluate and re-rank the proposals. Previously, the director was authorized to award contract when the highest rank proposal exceeded the \$6,000,000.00 estimate.
