A TRACT OF LAND BEING ALL THAT PART OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 2, TOWNSHIP 49 NORTH, RANGE 33 WEST, IN KANSAS CITY, JACKSON COUNTY, MISSOURI, THE CENTERLINE OF A PORTION OF A 25 FOOT WIDE CONDEMNATION FOR SEWER RIGHT-OF-WAY, BEING 12.5 FEET EITHER SIDE AND PARALLEL WITH SAID CENTERLINE BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A FOUND IRON PIPE LOCATED AT THE INTERSECTION OF THE SOUTHERLY RIGHT-OF-WAY LINE OF 11TH STREET (60 FOOT WIDE PUBLIC RIGHT-OF-WAY) WITH THE WESTERLY RIGHT-OF-WAY LINE OF HARDESTY AVENUE (60 FOOT WIDE PUBLIC RIGHT-OF-WAY);

THENCE SOUTH 89 DEGREES 40 MINUTES 23 SECONDS WEST, ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 59.58 FEET TO A SET IRON ROD WITH CAP;

THENCE SOUTH 69 DEGREES 01 MINUTES 09 SECONDS WEST, ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 159.78 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED CENTERLINE;

THENCE LEAVING SAID SOUTHERLY RIGHT-OF-WAY LINE, SOUTH 53 DEGREES 12 MINUTES 30 SECONDS WEST, A DISTANCE OF 295.94 FEET TO A POINT OF CURVATURE;

ALONG A TANGENT CURVE TO THE RIGHT, HAVING A RADIUS OF 200.00 FEET, AN ARC DISTANCE OF 182.45 FEET TO A POINT OF TANGENCY;

THENCE NORTH 74 DEGREES 31 MINUTES 30 SECONDS WEST, A DISTANCE OF 82.57 FEET TO A POINT ON THE AFOREMENTIONED SOUTHERLY RIGHT-OF-WAY LINE OF SAID 11TH STREET, AND THE TERMINUS OF SAID CONDEMNATION FOR SEWER RIGHT-OF-WAY CENTERLINE.
